Hilt Tatum, Jr., DDS, who has not presented at an Academy Annual meeting for many years, will be presenting on the topics of creating space (bone manipulation) and 24 guidelines for successful implant treatment.

"It is truly a pleasure to be presenting for the Academy in New York. It promises to be an extraordinary meeting," Dr. Tatum said.

Manual Chanavaz, MD, DDS, will speak on New Exciting Anatomical Considerations and Successful Bone and Soft Tissue Healing in Implant and Reconstructive Surgery. He will be accompanied by 29 other Lille University (France) faculty and students, many of whom will be presenting table clinics.

"As a professor of oral and maxillofacial implant surgery, I see this meeting as a unique opportunity for all dentists to learn and acquire the most recent information on basic medical and clinical sciences that are so critically important to improving and maturing their clinical skills," said Dr. Chanavaz.

Dr. Scott Ganz will present two main podium and one limited attendance lectures, and **Craig Cooper, DDS**, will present his always sold-out lecture on marketing dental implants at a limited attendance workshop.

"Limited attendance workshops are restricted to a certain number so it is important to register for the meeting immediately and make selections for these events that are available on a first-come, first-served basis," said General Chairman **Kim Gowey, DDS**.

An Allied Dental Staff program that covers all areas of the dentists' practice will be inspiring for staff and very beneficial for the dentists' practice.

"Members received their Preliminary Programs (with registration form) in the mail in June and I urge everyone to register immediately and make their hotel reservations as New York is a busy city," said President **Fran DuCoin, DMD**. "Last year our hotel sold out in Hollywood and this year New York has many events including the NY Marathon running concurrently with our meeting."

Perhaps the responsibility I have enjoyed most as your President, and before that over the past few years as an Officer, has been the opportunity to represent the Academy in many places and visit with so many fascinating members. Our members are achieving remarkable success in providing dental implant education in both the surgical and restorative phases, which will ultimately help people enjoy the quality of life they deserve. At the same time they are promoting our Academy worldwide.

Where do I start? Dr. Jamie Lozada's work at Loma Linda University in California is known throughout the world (and as a friend of mine recently said, that pretty much must mean throughout the known intelligent universe!). I was fortunate to spend a weekend at Loma Linda when the Western District meeting was held there: I wish I had had more time. Wow. two simultaneous live surgeries projected on large screens behind scientific presentations given to a packed room. Dr. Lozada was not only able to keep everything straight, but also make it very informative and interesting. But that was only a weekend. Besides being the AAID Treasurer and chairman of the Education Committee. he is also

Director of Implant Dentistry in the Advanced Education Program at Loma Linda, which is a three-year postgraduate course in the most advanced and sophisticated techniques taught in implant dentistry, and runs the 30th Annual Implant Dentistry Study Club (did you catch that, 30th Annual) at Loma Linda. This is a one-year, nine part, limited admission study club whose members travel far, very far, to attend. Why? Because if you really want to understand the art and science of dental implantology, it just does not get any better. In 2005 the Western District meeting is scheduled to be at Loma Linda again. I will be there. You should try to be there too; it will be worth it.

There are other programs that are at least equal and just as distinguished. Last fall, while visiting my new granddaughter (oh, and my daughter and son-in-law, too) in Paris. I took some time to call on Dr. Manuel Chanavaz. Professor and Chairman. Department of Oral and Maxillofacial Surgery, on the first day of classes at Lille University Medical School in France. What a pleasure it was to spend time with this gracious man, who is a true gentleman, and his lovely wife. He showed me his latest innovations in a room packed from floor to ceiling with instruments he has developed. He never slows down. The time was too short. but the day will always be remembered.

If you have not yet had the occasion to spend time with these men in their own locale, I'm pleased to inform you that they all will be coming to see you at the 53^{rd} Annual Meeting of the AAID in Times Square, New York City, from November 3 to 7, 2004. (See registration form on page 15.) It will be an incredible meeting and the <u>first</u> <u>time</u> these three men have been on a program together.




Each year, the examinations will be held in Chicago; and the application deadline is February 1.




