BOARD REPORT

President DuCoin presided over the June 2004 meeting and the following members of the Board were present: Drs. O'Grady, Gowey, LaMar, Lozada, Mills, Cranin, Cooper, Buttacavoli, Rosenlicht, Machi, Svoboda, Phillips, Potts, and Bush. Dr. Cullen attended the meeting as a representative of the Southern District. Mr. Shuck, Executive Director, and Dr. Recker, Legal Counsel, were also in attendance.

District representatives reviewed activities in and financial information for each district. Based upon the request of the Western District, the Board approved the transfer of District membership of Dr. Soderstrom from the Central to the

Western District.

Dr. Recker reported on issues related to the Academy's suits in California and Florida. The AAID legal consultation program was reviewed and it was noted that few credentialed members have used the services; however, the Board agreed to continue the program and Dr. Recker agreed to offer the services pro bono provided that the utilization does not increase substantially.

The Board reviewed the summary information related to the 2004 Annual Meeting, including registration data, program schedule, sponsorship, and marketing activities

Drs. O'Grady and Gowey summarized activities related to the

upcoming meetings. Dr. O'Grady noted that the 2005 committee had discussed the need for changing the manner in which the meeting's Presidential Sponsor was selected. Following discussion, this was referred to the Annual Meeting Planning Committee.

Dr. Lozada reviewed the Treasurer's report and noted that the Academy had once again received an unqualified annual audit. In addition, the April 30 financial statements were reviewed.

The Board reviewed a list of Associate Fellows and Fellows who were delinquent in paying their 2004 dues. Board members agreed to contact several individuals and that those who have not paid their dues by July 1 would be dropped from membership in accordance with the Bylaws requirements.

The Board reviewed the executive director's report and noted that the submission of the previous six reports had a direct or indirect impact on a number of Academy successes. In addition, it was noted that the Academy has continued to strengthen its financial position, increase its membership and credentialed member numbers and achieve legal successes. The report outlined staffing patterns and it was noted that there has been no increase in the number of staff since the addition of the part-time Chief Financial Officer in 1996. Since then, membership and annual meeting attendance have increased, the number of financial transactions has increased.



assistance to sponsored organizations has increased, Academy marketing activities have increased, the number of committee meetings and conference calls have increased, and the number of candidates taking the Associate Fellow examinations has increased. All of these increases have occurred without an increase in management or support staff; therefore, the Board authorized the addition of one full-time administrative assistant, effective immediately.

Dr. O'Grady reviewed his report and noted that he would soon inherit the office of President of a very successful organization and noted that past leaders have created a sound financial base, membership growth, unbiased educational opportunities and the only bona fide credential in implant dentistry.

Dr. O'Grady reviewed the ABOI report, which included information on the joint liaison committee meeting, ABOI/ID financial statements and audit, new Diplomates, activities at the 2004 annual meeting, and the 2004 promotional activities.

The Board noted that the committee was informed that the ABOI is considering a change in its requirements in order to allow international dentists to qualify more readily for the examination. ABOI candidates now must, 1) hold a U.S or Canadian license; or 2) be a graduate of an ADA Commission on Dental Accreditation-approved dental specialty program; or 3) be a graduate of a full-time post-doctoral dental implant program approved by the

PRO BONO LEGAL GUIDANCE

As an added membership benefit for credentialed members, the Academy is now offering free legal guidance through the expertise of General Counsel Frank Recker, who will provide generic legal information on the following subjects:

General risk management issues such as disgruntled patients, terminating patients, informed consent, patient records, non-cooperative patients, refunding fees for services rendered, patient payment/collection issues, patient demands for compensation, and standard of care issues

State dental board issues such as complaints, contact by investigators, a particular state requirement, and producing patient records

General business issues such as hiring protocols, dentist employee contracts, independent contractors, terminating employees, restrictive covenants, and employee handbooks

The service is limited to a maximum of one-hour per month for any credentialed member. AAID. These and other elements were put into place in order to closely emulate the credentialing requirements of the ADA-recognized specialties. According to the ABOI, the consideration of the revision is based on the ABOI's desire to elevate the stature of the ABOI/ID globally. Following discussion, the Board unanimously agreed that the ABOI's expansion into the international community may not be appropriate at this time and authorized the President to convey the Board's concerns to the ABOI/ID.

The Board appointed Dr. Paul Johnson to complete a vacant unexpired term on the A & C Board.

The Board agreed to endorse the three amendments proposed by the Bylaws Committee. These amendments address the following issues: delete Article IX, Section 14; correct the reference to the Research Foundation in Article XIV, and eliminate the specific composition of the Global Committee in Article IX, Section 10.

The Board reviewed the Education Committee report on sponsored continuing education courses, an approved course in Lebanon, revisions to MaxiCourse® Guidelines, and Academy's visibility in dental schools. The Board authorized the committee to solicit corporate sponsorship of continuing education courses.

The Board considered the financial report and accepted the report of the independent auditors, dated continued on page 6

December 31, 2003; approved the reappointment of Ruzicka Associates as the AAID's independent auditors for the calendar year 2004; approved the Delaware Place Bank as the new AAID's bank for lock box, checking and money market accounts, and approved the selection of North Star Trust Co. to manage the Academy's investment portfolio.

The Internet Committee suggested that the AAID newsletter be moved from the members-only sec-

tion to the regular access section to which the Board agreed. In addition, the Board authorized an additional budget of \$3,000 for changes to and upgrading of the Academy's site, and approved Dr. DuCoin's recommendation to appoint Dr. John Fish as the committee's chairman.

The outside strategic planning consultant provided an overview of several modifications to the plan that were developed based on the Board's discussions the previous day. The Board adopted the Strategic Plan as revised and amended.

In preparation for the special order of business, the Board

reviewed several issues related to the India MaxiCourse® including corporate sponsorship and established that all MaxiCourse® agreements should be for a one-year term.

Dr. Phillips reviewed Marketing Committee's report and recommended that the Academy engage a firm to develop a generic infomercial on the topic of implant dentistry that could be used by credentialed members. Following discussion, the Board authorized the expenditure of up to \$10,000 for the project and asked the Executive Director to review the arrangements

and to negotiate an agreement, as appropriate. The Board agreed that the launch of the new Academy logo would be held during the Opening Ceremony at the 2004 Annual Meeting.


Dr. Cranin reported on the status of the *JOI* application to Index Medicus and the 2003 annual meeting articles submitted to *Practical Procedures and Aesthetic Dentistry*. The Board concurred with Drs. Cranin and Mills that the esthetic conference presenters should withdraw their articles from PPAD and submit them to the JOI.

The Board agreed with the Site Selection Committee's recommendations that as long as a favorable arrangement can be negotiated with an outside meeting planner, no changes should be made and that the new composition and policies for the Annual Meeting Planning Committee as outlined in the committee's report be approved. In this regard, the committee composition will be expanded and the committee will assume responsibility for several future annual meetings.

Dr. Mills reported on a planned Leadership Summit and the Board agreed to sponsor the event. Dr. Mills agreed to provide a date and additional information at the November Board meeting.

The Executive Director provided a status report on the activities of the National Coalition of Credentialing Organizations, including his meeting with the ADA Executive Director.

The Board noted that several tactics approved in the Strategic Plan related to public relations activities; therefore, the Board created an Ad Hoc Public Relations Committee and authorized the President to recommend committee members.

EDITOR'S INTERVIEW WITH THE INCOMING PRESIDENT

DR. HOCHBERG: DR. O'GRADY, AS THE INCOMING PRESIDENT, THE MEM-BERSHIP WOULD BE INTERESTED IN LEARNING MORE ABOUT YOU. HOW DID YOU BECOME INTERESTED IN IMPLANT DENTISTRY?

Dr. O'Grady: My private practice is in Columbus, Ohio and I graduated from Ohio State Dental School in 1976. I've been involved in implants since the early '80s. Early in my practice I was involved with several patients who lost teeth due to auto accidents. It seemed to me that cutting down natural teeth was a very poor way to restore them. Dr. Heller and Dr. Hahn had just started providing some courses at that time. I went to their lectures and saw the benefits of implants for my patients. After that I started attending the Alabama Implant Study Club and the AAID meetings. I took courses along the way. I saw the AAID as a very viable force in implant dentistry.

DR. HOCHBERG: HOW DO YOU THINK YOUR EARLY INTEREST IN IMPLANT DENTISTRY WAS BENEFITED BY YOUR ASSOCIATION WITH THE ACADEMY AND HOW COULD POTENTIAL MEMBERS OR YOUNG DENTISTS JUST GETTING INVOLVED IN IMPLANT DENTISTRY BEN-EFIT BY THEIR ASSOCIATION WITH THIS ACADEMY?

Dr. O'Grady: I was amazed that even as a neophyte in implant dentistry I could ask the lecturers very specific questions and they were all willing to give advice. They offered any advice they could to help me further my education. And there's a great camaraderie with the members of the Academy. They're a very giving group of individuals.

Dr. Hochberg: Would the word MENTOR OR MENTORSHIP COME TO MIND?

Dr. O'Grady: Well in a nutshell, you can find mentors in the Academy and they're not afraid to answer the phone and give you some advice. Dr. Heller and Dr. Hahn were my early mentors, but since then I've had many mentors. I've gotten a lot of information from many verv dynamic individuals.

DR. HOCHBERG: OVER THE YEARS, YOU MOVED UP IN THE ACADEMY LEAD-ERSHIP AND YOUR LEVEL OF ACTIVITY INCREASED. NOW YOU FIND YOURSELF AS OUR INCOMING PRESIDENT. WHAT ARE SOME OF THE ISSUES THAT ARE PRESSING TO YOU AND THE ACADEMY AND ALSO SOME THOUGHTS ON HOW WE MIGHT GO ABOUT ADDRESSING THEM?

Dr. O'Grady: Last year, Dr. DuCoin started a strategic planning process. That plan was formalized and

approved by the Board of Trustees at its June Board meeting. The committees will be assigned specific tasks, and then the officers will work closely with the committees and committee chairs to achieve the strategic goals. The overall goal is for the academy to once again become the pre-eminent Implant Academy.

One of the main areas of focus is our membership. Fortunately, over the last several years our retention rate has been high, approximately 90%. But the one thing we need to do is to recruit new members. We need to get the message out to young dentists that the AAID is the place for education and credentials in implants. We have started some grass-root efforts with the dental schools involving the juniors and seniors. We're going out to the young practitioners to let them know who the Academy is and what we do. We are focusing on education outside of our exceptionally well-received annual meeting. A lot of continuing education has been instituted. We have the hands-on bone-grafting course, which has been expanded this vear. There's a course on soft tissue aesthetics. Also, a course on marketing, one on imaging, and a new course this year, which is an overview of implant surgery and prosthetics are being offered. So the education committee has done a great job in offering a lot of education courses, and that's pretty much what the academy is about, education.

Dr. Reynolds started the first Maxicourse® 18 years ago, and now we have three Maxicourses®. One at the Medical College of Georgia, one in New York, and our first international course in India.

DR. HOCHBERG: DR. O'GRADY AS

YOU DISCUSS SOME OF THE GOALS AND ISSUES THAT ARE AT HAND, TALK A LITTLE BIT ABOUT WHAT YOU THINK MAKES US UNIQUE COMPARED TO SOME OF THE OTHER IMPLANT ORGANIZATIONS.

Dr. O'Grady: We are the only academy that offers bonafide credentials that are only given after psychometric-based testing, and it's not a small feat to achieve these credentials. Credentials demonstrate to both yourself and your peers that you have firm knowledge not only of the surgical but also the restorative skills necessary to practice implant dentistry, at the highest level. We find that many dentists place implants, but very few have taken the time and effort to demonstrate their proficiency in the many disciplines for the implantologist. These credentials demonstrate to both your peers and your patients that you have achieved confirmation of your implant knowledge.

Presently we are ensuring our members have the right to announce their credentials by waging lawsuits in Florida and California. The Academy has, in the past and continues today, to protect the right of the dentist who both places and restores implants.

DR. HOCHBERG: DR. O'GRADY LET'S CHANGE THE SUBJECT A LITTLE BIT. IF YOU WOULD BE SO KIND, TALK A LITTLE BIT ABOUT YOURSELF. SHARE SOME THOUGHTS WITH THE MEMBER-SHIP SO THEY KNOW A LITTLE BIT MORE ABOUT YOU.

Dr. O'Grady: My wife, Kay, and I have five children. And we enjoy visiting them and traveling with them. Fortunately, they're all about out of college so we're looking forward to being able to spend some time in

Colorado, Boston, and Columbus where our children live.

DR. HOCHBERG: DO YOU HAVE ANY SPECIAL CLOSING THOUGHTS THAT YOU WOULD LIKE TO SHARE WITH THE MEMBERSHIP?

Dr. O'Grady: We are fortunate to have a very hard working and efficient Headquarters Office staff. We have a very good group of officers, committees, and chairs of the committees. This is really what makes the Academy great because we have so many hard working people in the Academy. I just ask the members to continue to support the annual meeting and the district meetings, because this support really is what makes the Academy tick.

DR. HOCHBERG: ON BEHALF OF THE ENTIRE ACADEMY, WE CERTAINLY WANT TO WISH YOU THE VERY BEST AND WE KNOW FOR THE UPCOMING YEAR, WE ARE ALL IN GOOD HANDS.

AAID Cadaver Bone Grafting Course Scheduled in June 2005

The next AAID Cadaver Bone Grafting Course will be held June 24 - 25, 2005, at Wright State University School of Medicine in Dayton, Ohio. This will be the fourth annual presentation of the course, which receives consistently high marks from the participants.

In addition to a comprehensive review of head and neck anatomy, including the tempromandibular joint, the course includes chin, ramus and subantral grafts, soft tissue management around implants, platelet-rich plasma and perioperative pharmacology. Lectures are followed by supervised laboratory sessions where participants perform dissections and grafting procedures on cadavers and practice acquisition and utilization of platelet-rich plasma with implant and bone grafting procedures.

The lecturing faculty includes James L. Rutkowski, DMD, Clarion, PA, course director; Craig D. Cooper, DDS, Indianapolis, IN; Richard Borgner, DDS. Clearwater, FL;and **Barry** Loughner, DDS, Orlando, FL. Drs. Rutkowski, Cooper and Borgner are Fellows of the Academy and Diplomates of the American Board Oral Implantology/Implant Dentistry. In addition to his dental degree, Dr. Loughner has a MS degree in Anatomy and a PhD Neurophysiology. Laboratory instructors James Fennell, DDS, Norwood, OH; and Daniel Camm, DDS, Brunswick, OH will lead a Lunch and Learn session about Bone Grafting Materials.

LILLE UNIVERSITY MEDICAL SCHOOL — A FRIEND OF AAID

One of World's oldest university programs in implant dentistry. Lille University Medical School, France, a friend of the AAID

On October 14, 2003, the Department of Oral and Maxillo-facial Implant Surgery, of Lille University Medical School inaugurated its nineteenth academic year (2003-2004) dedicated to the teaching of implant and reconstructive surgery since its creation in 1985.

On this occasion the Department had the privilege of honoring the American Academy of Implant Dentistry in the person of its then President-elect, Dr. Francis DuCoin who co-presided at the inaugural ceremony.

He was not in a strange company, as many of Lille University's past and present residents constitute the quasi-totality of French credentialed members of the AAID.

The implant program at Lille University is the only post graduate

University Diploma Program in the world based at a medical school.

Originally it was a two-year residency program leading to a postdoctoral diploma (the American equivalent of Master of Science) in Implant and Reconstructive Surgery. The teaching infrastructures were located at the Department of Oral and Maxillofacial Surgery, which is a

specialty of medicine and not dentistry in France.

In 1988, an extension of two years to the program was created for the first diploma leading to a second University Diploma (M.M.Sc.) in Advance Implantology and Reconstructive Surgery.

In the following year a University Research Doctorate (the American equivalent of Ph.D.) program on the basic sciences of implantable systems and biomaterials was established.

Department of Oral and Maxillofacial Implant Surgery was created within the Medical School of Lille University under the chairmanship of Manuel Chanavaz.

Up to this date 217 students have received their first Diploma and 17 have obtained their second Diploma. Six students have obtained the Research Doctorate.

Since 1987, in addition to the

French permanent faculty the following doctors, affiliated with the AAID were made Associated Professors on an annual basis: Leonard Linkow (1987-98), Hilt Tatum (1987 till today), Eugene Roberts (1987-till today), Carl Misch (1987-90), Jack Hahn (1987-90), Hans Grafelmann (1987-92) and Robert James (1987-1994).

Many other internationally renowned doctors such as Norman Cranin, Jack Lemons, Kenneth Judy

and Karl Eric Kahnberg have also contributed to the program.

In addition to French residents, 32 doctors from overseas have been trained in the department. These have essentially come from Algeria, Belgium, Denmark, Egypt, Germany, Great Britain, Greece, Holland, India, Ireland, Israel, Lebanon, Morocco, Syria, Saudi Arabia and United States.


One of the major activities of the Department, for the past fifteen years, has been its organization of the semi-annual intensive course in France on "The Serial Anatomy of the Head and Neck and Cadaver Dissection." It is attended by many doctors from all over the world. These courses have also been organized in collaboration with a number of other universities such as Indiana. Loma Linda, San Juan Tennessee in the US, Guttenberg in Sweden, Madrid in Spain and more recently, King Abdul Aziz in Saudi Arabia.

The Department is organizing the Twentieth Anniversary of its programs in May 2005.

The forthcoming academic year will be starting on October 11, 2004 and the annual serial Anatomy and Cadaver dissection, conducted in English, December 8-12, 2004.






A unique way to help the Foundation
