LEGAL VICTORY IN CALIFORNIA!

On September 8, 2004, the AAID scored a major victory in its ongoing legal efforts to secure the right of AAID members and ABOI Diplomates to publicly announce their Fellow or Associate Fellow and Diplomate credentials.

In the case, which was jointly filed by **Michael L. Potts, DDS**, a Fellow of the Academy from Camarillo, California, the Academy challenged a recently enacted California statute that only allows the advertising of those dental specialty credentials recognized by the American Dental Association (ADA) or the Dental Board of California. The Academy argued that the statute violates commercial speech protection under the



First Amendment because the advertising of Fellow or Associate Fellow and Diplomate credentials, though not recognized by the state dental board or ADA, does not inherently or actually mislead the public.

The US District Court for the Eastern District of California, where the case was filed, agreed and ruled in favor of the Academy and Dr. Potts. In his summary judgment, the judge

November 2, 2004

Mr. Shuck, Executive Director, and Dr. Recker, Legal Counsel, were also in attendance.

At its November 2004 meeting, the Board reviewed the ongoing activities of the National Council of Dental Credentialing Organizations and agreed to provide up to \$5,000 to the NCDCO in 2004 in order to assist this organization to become active.

The American Board of Oral Implantology/Implant Dentistry (ABOI/ID) participated in the 2004 annual meeting of the American Academy Implant Dentistry (AAID), which was held in New York City. In addition to convening the 10th annual breakfast, a lunch and learn session *On Becoming a Diplomat*, and an exhibit, the ABOI/ID held table clinics sessions on both Thursday and Friday during the meeting. Furthermore, the AAID offered a special mock board luncheon session for prospective Diplomates.

Through attending each of these activities, dentists interested in applying for the ABOI/ID's certification examination had an opportunity to

ask questions and to learn more about the various aspects of the examination process.

yet another success for the AAID Annual Meeting.

found that, while the State has an interest in preventing the public from being misled by erroneous advertising, the voluntary nature and stringent requirements of the AAID's and ABOI's credentialing process do not warrant a prohibition of announcing AAID and ABOI's credentials.

In essence, the District Court judge's decision effectively reaffirms the Academy's standing as a bona fide credentialing organization. In reaction to this latest victory, Academy President Kevin J. O'Grady remarked, "we are indebted to Dr. Michael Potts for his willingness to join us in this effort, which has such meaning for our profession."

This case represents the third of its kind in the State of California. Previously, in the 2000 case Bingham v. Hamilton, the Academy challenged a similar California statute prohibiting dentists with AAID credentials from publicly announcing and pro-

moting those credentials. The court ruled in favor of Bingham and the Academy, striking down the prohibition on advertising. However, the court also instigated the required use of a disclaimer on any public listing of the credential as an effort to protect the public.

Two years later, the California legislature enacted a new statute that codified substantially the same advertising restrictions as those struck down by the Bingham case in 2000. It was this 2002 statute that led the Academy and Dr. Potts to file suit with the US District Court.

What happens now?

Following the District Court's ruling, the AAID and the California Dental Board will meet with the presiding judge to discuss the relevancy and practical outcomes of his decision. At the time of this article, the date of that meeting is unknown.

A potential source of debate in this discussion may be the role of disclaimers when a dentist announces

his credentials, similar to what was implemented as a result of Bingham v. Hamilton. The use of these disclaimers generally becomes an onerous burden on dentists as they develop any form of marketing materials or signage for their practices. If successful in arguing its rationale for the use of disclaimers, the California Dental Board could unquestionably induce a chilling effect on the District Court's ruling.

Following this meeting with the judge and Academy, the California Dental Board will then have 30 days to appeal the District Court's decision. If such an appeal is filed, Dr. O'Grady is resolute that the Academy will continue its legal efforts to support the rights of its credentialed members. "Without question, the Academy will carry on with these efforts," he says. "Our credentialed members must have the choice to freely announce their credentials and to do so without undue hardship from state laws or regulations."

approved at the June meeting of the Board of Trustees. It was noted that individuals must be given specific responsibilities and be held accountable for their assignments. It was noted that these assignments would be confirmed during the committee's February 2005 meeting.

Dr. O'Grady summarized the report of the Liaison Committee and noted that the ABOI/ID had amended the ABOI Bylaws to allow either an AAID Fellow or Associate Fellow to serve on its Board of Directors. Currently, a Director must be a Fellow. Based on the Liaison Committee's recommendation, the Board of Trustees ratified the ABOI Bylaws amendment. The Liaison Committee was asked to discuss various options for the Academy to continue its financial support of the ABOI, including but not limited to, sponsorship from other organizations.

Dr. O'Grady reviewed the Bylaws Committee's report and the three amendments that would be discussed at the 2004 Business Meeting. The Board agreed that the proposed amendments should be approved.

The Board considered the report of the Ethics Committee and approved the committee procedures. The Board agreed that there is no need to add the procedures to the Bylaws via an amendment since the procedures are now in place and the Headquarters Office provides administrative assistance to the committee.

Dr. LaMar reviewed the actions from the Global Committee's

September meeting. Based on the committee's recommendation, the Board approved Alain Clairret, DDS; Triny DeFranco, DDS; Marius De L'Isle, DDS; Gong Ping, MD; and Xiaojiang Yang, DDS as global Delegates. The Board noted the committee's efforts to develop a meeting in an international setting and asked the committee to bring details about a meeting in Ireland to the February 2005 Board meeting. In the discussing the opportunity to develop a MaxiCourse® in Iran, the Board agreed that a course could be developed for Iranian dentists, but it decided that the course should not be located in Iran at this time. However, the Board agreed that Dr. LaMar could visit the country and submit a report to the Education and Global

Committees for their review and recommendation. President DuCoin referred the committee's request that the Academy conduct at least one global or international event at each annual meeting to the Annual Meeting Committee for its review. The Board approved the committee's recommendation of Dr. Jihad Abdallah as the Global Dentist of the Year. Dr. DuCoin asked the Global Committee to analyze the format of and need for the Global Breakfast during the Annual Meeting inasmuch as the attendance has been declining. In addition, Dr. DuCoin expressed his appreciation to Dr. LaMar for his guidance to the Global Committee for the past several years.

Dr. DuCoin reported that a firm had been selected to create new

design concepts for the Academy's web site.

Dr. Buttacavoli reviewed the Membership Committee's report and noted that total membership had increased to a new record of 2,590 members. The Board reviewed the committee's recommendation related to a proposal from a student AAID member and agreed to conduct a pilot project to determine the success of recruiting new members. In this regard, the Academy will cooperate with the students at the University of Detroit Mercy School of Dentistry, offer the regular student membership at \$50 and donate an amount to the student organization.

The committee's recommendation for the dues of recent graduates was adopted in accordance with the following criteria:

Year 1 after graduation - \$100

Year 2 after graduation - \$200

Year 3 and thereafter - Dues rate in effect at that time

Dr. Phillips reviewed the Marketing Committee's report and disseminated samples of various printed materials. The Board raised several questions about the projects underway by the committee, the coordination of these projects with other committees and the proposed costs. The Board referred the projects to the Finance Committee with the request that the chairman of the Marketing Committee provide sufficient information for the Finance Committee to analyze the projects, including the costs and application. The Board requested that the information be provided to the Finance

Committee by December 1 and that the Finance Committee provide a report to the Board at its February 2005 meeting.

The Board agreed that the lapel pins purchased by the committee should be disseminated to the Annual Meeting attendees and that the committee could sell the clothing items during the meeting.

Dr. Cranin reviewed the Publications Committee report and the Board reappointed some members of the Editorial Board and Associate Editors whose terms expired at the end of 2004. In addition, Dr. Emile Martin was added to the Editorial Board. The Board also reviewed the informational report from the Newsletter Editor.

Dr. Svoboda reviewed the Speakers' Guild Committee's report and noted that the Guild recommended that it be given the opportunity to accept Guild members who are not credentialed members of the Academy. The Board approved the request.

The Board authorized the Executive Director to finalize an agreement with the New Orleans Riverside Hilton for the 2009 meeting and noted that should an agreement not be reached, that the Executive Director could negotiate a final agreement with the New Orleans Marriott.

Dr. Lozada reviewed the September 30, 2004 financial statements. The proposed 2005 budget contained income from revenue and investments of \$1,900,000. Expenses totaled \$1,784,000, creating a projected surplus of \$116,000. The direct and indirect support to the Research

Foundation totals \$36,000 and to the ABOI/ID totals \$130,000, which included \$13,450 in promotional activities and \$13,800 to replenish the ABOI reserve fund per the agreement. Following discussion, the 2005 budget was approved.

The Board reviewed informational reports from several committees including A & C Board, Education, Honored Fellows, Nominating, Performance Review, Study Clubs, Auxiliary CE, and the Report from the AAID Research Foundation.

Dr. Weiss, the Director of the India Maxicourse[®] presented information on the recently completed first year course and confirmed that plans are underway to hold a second course in 2005. Further, he indicated that there was interest in offering also a MaxiCourse[®] in Jordan. The Board agreed that it could support this course provided appropriate arrangements can be made in accordance with the Academy's policies.

Dr. Mills reported on the plans for the Leadership Summit and the Board agreed that the meeting should be open to non-AAID members.

Dr. DuCoin noted that the 53rd year of the American Academy of Implant dentistry had been one of progress, growth, and accomplishments. He pointed out that the greatest achievement this year was the creation of the Academy's first strategic plan, the three-year project titled "Campaign 2004: A Clear and Future Course." The Board acknowledged the important role Dr. DuCoin played in the Academy's success during 2003-2004 and thanked him for his efforts on behalf of the Academy.

EDITOR'S INTERVIEW WITH DR. NATALIE WONG



Dr. Wong is newly credentialed as an ABOI Diplomate and a Fellow in AAID.

Hochberg: Dr. Wong, it is a pleasure to sit down with you and take a few minutes to chat. How did you find out about the AAID?

Wong: I've been a member of different organizations and I was interested in more knowledge and more credentialing. My advisor advised me to join AAID. The ability to get more credentials was important to me.

Hochberg: Tell us a bit about your training.

Wong: I studied at the University of Toronto under George Barr. I completed my residency program and wanted more practical experience.

So, I took a number of courses in implant surgery and bone grafting. I've found that bone grafting is necessary in a lot of situations. After researching a number of different companies, I took a more advanced program with Dr. Mitchell.

Hochberg: What was your impression of the process of credentialing?

Wong: It is definitely not an easy process. It takes a good deal of work and you have to allot time for it. One of the more time consuming parts is the documentation of cases through records and photos. Before embarking on this process, you should ask yourself if you have time to do all of this. Studying for the exams is mostly hands-on through your own private practice and dealing with patient management. Most of my study came from private practice – you will see complications in your day to day tasks. If the work you do is all-perfect, you haven't been doing this long enough. Your skills are measured by your ability to deal with complications.

Hochberg: Was the AAID supportive throughout this process?

Wong: The speakers at seminars are always relevant and helpful. The seminars are very applicable to real

life experiences. The speakers are not afraid to document their successes and failures. I found them to be forthcoming, honest, and welcoming. I enjoy the "mini-courses" because it allows me to "nit pick" at certain specific areas.

Hochberg: Tell us a little about your personal life.

Wong: My husband and I live in Toronto. I am now enrolled in a part-time prosthetic program at the University of Michigan in Ann Arbor and I commute back and forth. I also maintain a clinical practice in Toronto for "hands-on" application and study.

Hochberg: As a newly credentialed ABOI Diplomate and AAID Fellow, is there anything you would like to share with other members of AAID who might be contemplating credentialing?

Wong: I feel that continuing education as well as credentialing is very important to private practice, because patients really appreciate the fact that I take time out of my practice to learn about new technologies and techniques.
