Purpose: The purpose of this study was to analyze the differences of the diameter of the posterior superior alveolar artery (PSAA) and the distance of its inferior border from the sinus floor on Cone-beam CT images according to age and gender.

Materials & Methods:

CBCT images demonstrating the presence of PSAA in 60 subjects, which were divided into 6 groups according to age & gender: 21-40 Male, 41-60 Male, 61-80 Male, 21-40 Female, 41-60 Female, 61-80 Female. The diameter of PSAA and the distance of its inferior border from the sinus floor were measured.

Results: The mean diameter of the PSAA on CT

images was XX mm . The mean distance of its inferior border from the sinus floor was XX mm. The statistical comparison of the distance from PSAA to the sinus floor shows (no) significant difference between the gender & age groups.

Conclusion: When doing sinus elevation surgery using lateral approach, caution is needed at this region to avoid any potential vascular damage. CBCT scan is a valuable method in evaluating presence of sinus arteries before maxillary sinus surgery.


1st Place Table Clinic at AAID's 2011 Annual Meeting The Thickness of the Alveolar Buccal Bone after Immediate Implant Placement and Provisionalization: A Retrospective CBCT Evaluation

Abstract: A loss of buccal gingival architecture after

immediate implant placement procedures has been reported in animal study models. The aim of this retrospective radiographic evaluation is to evaluate the buccal bone behaviour in a human population after immediate tooth replacement. Thirty human subjects with a failing tooth in the esthetic zone will be included in this study. Immediate implant placement and provisionalization was performed and I-cat scans taken at implant placement, 6 months and 1 year. Vertical and horizontal buccal bone remodeling will be quantified on cone beam acquisitions. It appears from preliminary data that if, an appropriate implant positioning, implant diameter selection and bone grafting of the buccal gap is performed a predictable outcome in the preservation of the implant buccal aspect can be obtained.

stay active in your Academy.

This year we will work to make non-credentialed dentists and the public aware that the AAID is the only implant organization that can issue a court-recognized, bona fide credential. We will do so by implementing a strategy that places the AAID at the top of the search engines so that we are found by the thousands of doctors providing implant services and the millions of people looking for the best doctor to provide those services. Our reach will indeed be global.

We will build the infrastructure necessary to provide those who contact the AAID seeking a credentialed implant professional with accurate information in a helpful, friendly, and timely manner. AAID and **AAID** Research Foundation recognize outstanding dentists

The American Academy of Implant Dentistry recognized two dentists with the highest awards given by the Academy during its recently concluded 60th Annual Meeting.

Named the recipient of the Aaron Gershkoff Memorial Award was Robert J. Buhite, Sr., of Rochester, NY. Dr. Robert J. Buhite, Sr., earned his DDS in 1959 from the St. Louis University School of Dentistry. After graduation, Dr. Buhite served for two years in the United States Navy Dental Corps. Upon his discharge from the Navy, he entered private practice with an emphasis on implants in Rochester. New York. Dr. Buhite served as Editor of the Journal of Oral Implantology from 1970 through 1974 and was President of the New York State Academy of Dental Practice Administration for the 1974-75 term.

An Honored Fellow of the American Academy of Implant Dentistry and a Diplomate of the American Board of Oral Implantology/ Implant Dentistry, Dr. Buhite has also earned Fellow status in the Academy of General Dentistry, the American College of Dentists, and the International College of Dentists. He served as president of the American Board of Oral Implantology/ Implant Dentistry in 2005 and received the Distinguished Alumni

Award from St. Louis University in 2008.

The 2011 recipient of the Isaih Lew Memorial Research Award was Victor I. Sendax, DDS, of New York City, NY. Dr. Sendax has been instrumental in originating & developing the Sendax Mini Dental Implant System, (MDI) which was the pioneer mini implant concept, first conceived and researched in 1976. He was granted the only patent (1998) ever issued by the US Patent Office for a nonsurgical method to insert a mini dental implant without resorting to flap surgery or a conventional osteotomy.

He is currently completing the first comprehensive textbook on the MDI subject entitled: Mini Dental Implant Innovations, published by the Wiley-Blackwell Medical-Dental Textbook Publisher.



Victor I. Sendax, DDS

A graduate of the NYU College of Dentistry and a former member of the NYU teaching faculty, he also attended Harvard School of Dental Medicine Post-Doctoral Programs.

Dr. Sendax is a Past President of the American Academy of Implant Dentistry and was named an Honored Fellow of the AAID. He is also a Diplomate of the American Board of Oral Implantology/ Implant Dentistry and served as president of that Board. He is a prior recipient of the Aaron Gershkoff Memorial Award. He is a former member of the American Dental Association House of Delegates and is a Fellow of the American College of Dentists & International College of Dentists. Annual Business Meeting

A total of 206 Associate Fellows and Fellows attended the annual business meeting on October 22, 2011 in Las Vegas, Nevada.

President Joseph
Orrico and Dr. Kevin
O'Grady, chairman of the
Admissions and Credentials
Board, presented certificates
to the new Associate Fellows
and certificates along with
medallions to the new
Fellows. Dr. Orrico administered the AAID Pledge to the
new Associate Fellows and
the Fellows who had not
been previously inducted.

President Orrico began his report about the Academy's major accomplishments this year with remarks about the AAID's legal victories in California and Florida. This year, the state of California paid the Academy just under \$700,000 to cover a portion of its legal expense for the case that was closed in 2010. He noted that the Academy can now use both the California and Florida decisions as cautionary examples to other states that currently restrict advertising of credentials.

Among the other accomplishments that Dr. Orrico noted were:

- The election of 79 new Associate Fellows, two new Academic Associate Fellows and 16 new Fellows.
- The approval of four new AAID MaxiCourses®, bringing the total number of approved MaxiCourses® to 13.
- The upgrading and expansion of the *Journal*

of Oral Implantology.

- The success of the 2011 Annual Meeting with respect to the number of registrants, program content and financial results.
- The educational and financial successes of the meeting of the Northeast and Southern Districts.

President Orrico said that perhaps his proudest accomplishment — the marketing and public relations campaign directed to consumers — has not yet happened. The campaign, which is still in the early stages of planning, should be ready for initiation in 2012.

contributor to the science of implant dentistry.

Treasurer, **Dr. John Minichetti**, reported that 2011 was another successful year from a financial standpoint. This year, both the Annual Meeting and the total membership have grown, and the state of California awarded the AAID \$675,000 as partial compensation for its legal expense for the case that was settled last fall.

Next year's income, excluding unrealized and realized capital gains or losses, is forecast to be \$3,290,000 compared to projected 2011 income of \$4,142,714. The projected decrease is primarily due to two factors: the legal settlement fees that were

reimbursed in 2011 and due to the location of the 2012 annual meeting, revenue is projected to be \$187,000 less than this year. Membership dues and Annual Meeting revenue provide approximately 85% of the Academy's operating revenue.

Total expenses in 2012 are projected to be \$2,986,900, which is 7.5% more than the projected 2011 expenses of \$2,779,125.

Two new activities are planned in 2012. One is the Consumer Marketing Program, a national public relations and marketing campaign to increase public and professional awareness of AAID credentialed members and their stature as highly qualified dental implant practitioners.

The other is the Admissions and Board's conduct of a mock oral/case examination by web conferencing at the conclusion of the 2012 oral/case examinations for Associate Fellow and Fellow membership. The Board is considering offering the examinations by web conference at an international site on a periodic basis as an alternative to face-to-face examination of candidates who reside outside North America. The examiners would continue to be in Chicago.

Dr. Larry Bush, chairman of the ByLaws Committee, reported that no amendments were being presented for consideration at this meeting.

President Orrico presented a Presidential Citation to **Dr. Beverly Dunn**, AAID Historian, who researched, wrote and produced "On the Shoulders of Giants," the video that commemorated the Academy's 60-year history and its role in implant dentistry.

Newly-installed President, Larry Bush commented on the foundation that the pioneers laid and that subsequent leaders had built into what is today's AAID. He challenged the new Associate Fellows and Fellows to remember that their credentials are not a destination but the first step of a long journey. He urged them to be active in the Academy by attending meetings, becoming involved at the district level and volunteering for committees. 

AAID Commemorates 60 Years of Dental Implant Training and Advocacy

What better city than Las Vegas to celebrate a major milestone? The American Academy of Implant Dentistry (AAID) did just that by commemorating the 60th anniversary of dental implants during its annual scientific meeting here. Most of the 2,000 conference attendees were not around in 1951. At that time, dental implants had, at best, a dubious reputation among most dental professionals. What a difference 60 years makes — implants are now the standard of care for replacing missing teeth.

It is estimated that 69 percent of Americans age 35 to 44 have at least one missing tooth, and one in four over the age of 74 have lost all of their natural teeth. Aging Baby Boomers are fueling high demand for

dental implants, but the aggressive advertising aimed at them does not provide information they need about the procedure and qualifications required to perform it. Therefore, AAID's message in commemorating 60 years of dental implants is that implants promote good oral health and restore self-confidence, but successful outcomes are best assured by careful and informed selection of a highly trained and skilled implant dentist.

"What I believe is most compelling about AAID's history is the courage and confidence shown by the founders who stepped out of comfort zones and went against their professional societies to promote dental implant training and establish the AAID implant credentialing pro-

gram," said **Joseph Orrico, DDS**, President of the AAID during the 60th Annual Meeting. "Today, the AAID credential is the most rigorous and respected implant training program in the world. Without the vision and fortitude of our founders, implant dentistry would not be a mainstream procedure in dentistry."

AAID Pioneers Blazed a Lonely and Controversial Trail

Sixty years ago, a small cadre of dental pioneers braved a firestorm of professional criticism and met in Chicago to share ideas to stimulate research and training in implant dentistry. This was the beginning of the practice of implant dentistry and paved the way for eventual

public and professional acceptance of the procedure. That meeting led to another meeting held February 4, 1952, also in Chicago, with 14 dentists and four laboratory technicians. It was the inaugural conclave of the American Academy of Implant Dentures, which today is AAID.

In the 1950s, very few dentists were performing implants, and the nation's dentals schools refused to teach the procedure. "Implant dentistry had no respect. When we started doing implants, it was kind of a mentor system. You tried something out and if it worked, you told your friends and they did it or they'd come to your office to watch you do a procedure," recalled Norman Goldberg, DDS, a spry nonagenarian who served

nonagenarian who served as AAID's first president and who was present at the recently concluded 60th Annual Meeting.

"We had several people involved in implants after the informal sessions and decided it was too important go without further development. So we decided to form an academy to discuss the different problems that come up with implants and provide forums for everybody to learn from everybody else," said Goldberg.



A full crowd was in attendance at the scientific programs, many of which featured simultaneous translation from English into Spanish and vice versa.

As a young army dental officer, Dr. Goldberg was impressed by the ways broken and shattered bones were being treated with new procedures and implants and wondered why it couldn't be done in dentistry.

"I was reading about implants for different parts of the body and when I saw what was being done, I decided there's no reason we shouldn't try to replace teeth the same way by implanting on the jaw." Goldberg said.

Goldberg noted that the public accepted implants long before the dental establishment. People tired of wearing ill-fitting dentures were intrigued and looked for dentists who knew how to do the procedure. Later, as more was learned about the science of osseointegration, the fusing

of bone to titanium, which is used for dental implants as well as artificial hips and knees, implant dentistry became more widely accepted and predictable.

"The final piece to the credibility puzzle was to provide a credentialing

examination that was as challenging as the other dental specialty boards and reflected the professionalism that dental implantology had achieved," said Orrico. "AAID worked with experts in education to establish a credible and rigorous examination process for the American Board of Oral Implantology/ Implant Dentistry."

Today, the persistent work and advocacy of the AAID pioneers helped create interest and escalating demand for dental implants. The AAID's annual meeting has become the place to be for practice education for the practicing implant dentist.
