The purpose of this message is to reinforce the following points below concerning Yoke N621/ N623 cable grabs:

- 1. Importance of providing instructions to end users.
 - N621 / N623 are shipped to you with instructions
- 2. Reinforce proper use of N621 / N623.
 - max 9" (225 mm) connection length between carrier cable and attachment point on the N621, N623

- N621 / N623 cable grabs are designed to protect a worker in the event of a fall while climbing FIXED LADDERS OR SIMILAR CLIMBING STRUCTURES
- N621 / N623 must only be used on vertical cable systems. N621 / N623 are not to be used on cable that is angled or horizontal
