Role of Fiduciary (Reb Gregg)

ACCT Counsel shares thoughts, opinions, and feelings that pertain to the legal duties of a BOD member. **Key Points:**

- Promote and Advance the mission of the association
- Avoid any conflict or appearance of conflict with the association
- ACCT is Organized under Delaware Law
- 'Reasonable board member' test as pertains to litigation



- Duty of care is one of 'Loyalty and trust' advancing the association's interests above your own
- Lack of consideration or willful ignorance of problems or violations reported is a violation of the duty of care of the BOD
- BOD members from are protected from personal exposure by both the organization's status, and Directors/Officer insurance
- Conflict of Interest and Anti-trust policies are the most important to be mindful of.
