This award is intended to recognize employees of ACEC member firms for their accomplishments in community service.

1. **Name of Award:** ACEC Community Service Award

2. Nominations:

- ▶ Nominations for this award may be made by any employee of an ACEC member firm.
- ▶ Nominations are due to ACEC Tennessee by 11:59pm **Friday, October 4, 2024**, submitted electronically to Kasey Anderson, kanderson@acectn.org.
- ▶ All nominations must be complete and submitted electronically on the nomination form provided.

3. Evaluation and Selection of Nominees:

- ▶ The evaluation of the nominees for the award will be made by the Young Professional Award Subcommittee of the ACEC Tennessee Board of Directors. The Sub-committee will recommend the top nominee(s) to the board.

4. Criteria for Award:

- ▶ ***The nominees shall be outstanding individuals who have been involved in community service such as board, commissions or community groups and shall have demonstrated a sustained commitment to their communities.***
- ▶ The nominees shall be perceived by the public in their communities as leaders. The nominees may have been active in local, county or state government.
- ▶ The nominees shall have served to influence decision-making on issues other than professional.
- ▶ The nominees may demonstrate, through their civic involvement, how the quality of life in their community has been enhanced.
- ▶ The nominees shall have received no remuneration for professional services rendered, if any.
- ▶ The nominees shall be or have been a principal or manager in a member firm of ACEC for at least five (5) years.

5. Recognition:

- ▶ All winners will be recognized in person during the Engineering Excellence Awards Gala on November 6, 2024 at the Four Seasons Nashville.
