2026 Leadership PE

Program Overview



ACEC Tennessee's Leadership PE is a competency-based leadership program focused on senior, mid-level, and emerging high potential leaders in both the private and public sectors. The competencies included in this customized program inlude self-development, perspective, learning on the fly, presentation skills, conflict management, political savvy, delegation, listening, interpersonal savvy, and building effective teams. Program participants will gain leadership skills while networking with members from other ACEC Tennessee member firms asl well as federal government and state agencies.

The 2026 Leadership PE program will include a two-day orientation session and four additional monthly sessions of 1.5 days each. Sessions will be facilitated by experts in each competency and will include discussions with leaders from our partnering agencies, including the Tennessee Department of Transportation, Tennessee Department of Environment & Conservation, Tennessee Valley Authority, and U.S. Army Corps of Engineers. Sessions will typically include educational topics, team building activities, networking opportunities, and a tour of a partner agency facility. All participants who complete the course will be recognized in a graduation ceremony held in conjunction with the last session.

Leadership PE participants are selected through a competitive process open to persons working in Tennessee. Applicants must be full-time employees of an ACEC Tennessee Member Firm or public agency partner. PE or similar certification is strongly preferred.

Participants will be chosen by the Leadership PE Selection Committee based upon the information provided on this application. The committee will be seeking representation from a cross-section of the state in both private and public sectors.

Applicants must have been working in Tennessee for one year prior to submitting the application and have the full support of the organization or corporation they represent.
