Governor's Press Briefing Regarding Alcohol Delivery

Our President & CEO, Sarah Oates, has been working directly with Governor Dunleavy and his team throughout the day to implement the temporary relaxation of specific alcohol laws (currently effective through 11:59pm on May 11, 2020), in the interests of helping the hospitality industry during dire times, and in preserving public health by providing for increased social distancing options. His press release can be found here, and the specific language can be found on pages 12-13 of this document.

Please note that while this order is effective immediately, Alaska CHARR highly recommends that all applicable licensees wait until receiving official written notice from the Alcoholic Beverage Control (ABC) Board before beginning any of the following activities contemplated in the disaster order:

- Bona fide restaurant or eating places (including those who hold beverage dispensary licenses) to deliver beer/wine/cider with an order of food from that restaurant
- Beverage dispensaries, restaurant or eating places, package stores, breweries, brewpubs, wineries/cideries, and distilleries to conduct curbside delivery of the types of alcohol normally allowed for sale by the respective license type

Important Note:

The ABC Board has an emergency meeting scheduled to consider adopting emergency regulations **tomorrow**, **April 15 at 2:00pm**. The board may impose additional restrictions and will be considering specific procedures to promote commerce while ensuring the continuation of responsible alcohol control and public health and safety during this crisis.
