Last week, Sarah Oates – our President & CEO – urged the Alcoholic Beverage Control (ABC) Board during its regular meeting to pass advisory votes, requesting that Governor Dunleavy temporary relax enforcement of specific sections of law in order to help mitigate financial impacts on businesses while minimizing public health risks. Ms. Oates and industry attorney Jessica Brown were the only two people outside of the board itself to provide testimony at that meeting regarding these requests. While the ABC Board was ultimately convinced of the urgency to act immediately, their votes were strictly advisory in nature and require additional action to be taken by the Governor.

If either of these issues are important to you or your business, contact the Governor's office and ask him to concur with and implement the two advisory votes passed by the ABC Board that would:

1. Allow for restaurants, bars, and other establishments that sell alcohol for on-premises consumption to now sell factory-sealed beer/wine/cider to-go;
and
2. Allow for liquor stores, breweries, cideries, and distillers to conduct curbside

delivery of alcohol in order to reduce the number of individuals who are entering their premises, and help with social distancing and sanitation.

IMPORTANT NOTE: The above activities are **not** currently legal unless and until specifically announced by the Governor and the Alcohol & Marijuana Control Office.

The ABC Board will be having an emergency meeting tomorrow, Wednesday, April 8 at 1:00pm.
