- Access to free information and advice including regular Zoom calls from prestigious attorneys, CPAs, medical and insurance providers, and other experts
 - Town halls with Alaska's Congressional delegation for the hospitality industry
 - Direct meetings between industry members and federal, state, and local officials
 - Discounts on PPE and other COVID-related tools
 - Free mental health toolkits and webinars
- Drafting and adoption of new regulations that will soon allow for the hospitality industry to take mandatory alcohol server training via webinar statewide
 - Financial assistance and other support and relief for hospitality workers
