We have learned through conversations with government and public health officials that the number one factor that will enable our industry to remain open to the public is the ability to perform contact tracing. Businesses who keep visitor logs make contact tracing much easier, as business owners or public health officials are then able to directly contact individual patrons who were at the business during the same time as a confirmed COVID-19 public exposure, rather than potentially having the business name added to a publicized list. We strongly encourage businesses – particularly those with on-premises drinking and dining – to keep visitor logs in order to help aid you and your customers in the event of a public exposure.
