In a bright moment amidst an awful week for this country, we are pleased to announce that Congress has finally fixed the Paycheck Protection Program.

The PPP has helped countless businesses, but we are an industry with a particularly uncertain path to recovery and it simply hasn't worked for us.

Alaska CHARR and the National Restaurant Association were some of the first [to call for fixes to PPP](#) to preserve our imperiled industry. With the strength of your voice, Congress has finally acted. The Senate just passed the [Paycheck Protection Flexibility Act](#), legislation that would extend deadlines and relax restrictions on how loans are used. The president is expected to sign the bill very soon.

In an era where political discord is the norm and agreement is fleeting, the voice of the hospitality industry has been a unifying theme. This bill passed because Congress heard from us loudly, clearly, and

consistently. We appreciate the bipartisan work of Majority Leader Mitch McConnell (R-KY) and Democratic Leader Chuck Schumer (D-NY).

We especially appreciate Senators Lisa Murkowski and Dan Sullivan and their teams for their continued outreach, support, concern, and representation of Alaska hospitality businesses and entrepreneurs.

Alaska is unique in many ways, including in this crisis – our businesses have been impacted and will continue to be effected in ways and at levels that businesses in other states aren't. Our senators spoke loudly and fought tirelessly to ensure that legislation would be meaningful and useful to Alaskan business owners.
