



### ABC Board Regulations Projects

The Alcoholic Beverage Control (ABC) Board is currently seeking public comment regarding three different open regulations projects.

Alaska CHARR highly encourages industry members to read the proposed projects and submit comments to the ABC Board for consideration. #### Death of a Licensee:

This regulations project would clarify the restrictions, requirements, and procedures that must be followed when a licensee passes away, and recognizes that those should vary depending on the licensee's level of ownership in the business.

#### Repackaging by Package Stores:

This regulations project would allow for package stores to fill and sell growlers of cider.

**Internet-based Alcohol Server Course:**

This regulations project would allow for servers around the state to take alcohol server courses online via webinar or video teleconference, regardless of location or availability of in-person classes.

We saw lots of activity in Congress last week, including passage of a Democratic backed COVID-19 funding bill ([HEROES Act 2.0](#)) in the U.S. House of Representatives. In [today's video update](#), learn about what is included in the \$2.2 trillion stimulus package and how it compares to proposals offered by Treasury Secretary Steve Mnuchin and Senate Republicans. If Congress is unable to come to an agreement before November, we need them to enact essential funding for the hospitality industry, including a second round of the Paycheck Protection Program (PPP), until a comprehensive funding package is passed.
