



### ABC Board Special Meeting

The ABC Board is holding a special meeting next Wednesday, September 30 via Zoom to discuss enforcement priorities.

We are very excited about this discussion, as our President & CEO, Sarah Oates, worked tirelessly as a former Program Coordinator at the Alcohol & Marijuana Control Office (AMCO) to provide education and training for the industry. Ms. Oates has been steadfast in her desire to improve industry compliance through proactive education of the industry (webinars, seminars, one-page educational materials, helpful FAQs, etc.), rather than relying solely on education through enforcement tools like notices of violation (NOVs), accusations, and even criminal charges. We believe it is unrealistic to expect complete compliance of an industry when the only resource and information available is the 150+ page book of ambiguous and contradictory laws and regulations.

Ms. Oates was limited in her authority under her former role to effectuate those changes that would help the industry, which was a major factor in her decision to join the CHARR team where she could be more effective. During her first five minutes of meeting AMCO's current Interim Director, Glen Klinkhart, Ms. Oates planted the "proactive education" seed, and Mr. Klinkhart has run with it.

During next week's meeting, the ABC Board will be discussing implementing logical enforcement priorities and comprehensive enforcement procedures that will be publicly available for the first time. This should create consistency, fairness, and transparency in AMCO enforcement of the alcohol and cannabis industries. Additionally, Alaska CHARR will continue to work closely with AMCO and the ABC Board to help produce educational materials and training opportunities so that industry members may finally have a clear understanding of existing laws, rules, policies, and expectations.

### **ProStart: the Future Workforce of Alaska Hospitality**

We will work directly with you to get the ProStart program into your local schools by partnering to educate and communicate with those who determine which school programs receive funding.
