

Special Meeting of the Assembly re: Use of CARES Act Funds

The Anchorage Assembly will be holding a special meeting tomorrow, Friday, August 7th from 1:30 – 2:30pm to discuss the use of CARES Act relief funds for small business relief. At present, the Assembly is considering splitting \$7 million dollars amongst the entire tourism industry (including hospitality). Alaska CHARR and the Brewers Guild are proposing allocation of \$21 million dollars (out of the \$159 million total received by the Municipality) for those affected by the Mayor's Emergency Order 15, which has shut down or severely limited most hospitality businesses across the Municipality, resulting in the layoff of thousands of workers.

If you want to receive any sort of financial relief, then please contact the Anchorage Assembly **now** to share your stories, and let the Assembly know that the hospitality industry needs more support than what they are currently considering.

Anchorage Assembly Alcohol Tax Virtual Town Hall

The Anchorage Assembly is holding the second "virtual" town hall on *Thursday, August 6, at 6:00 p.m.* to present several proposed plans for uses of the alcohol tax and to receive public feedback on those proposed plans. Assembly Chair Felix Rivera said, "We've heard from the public that our community wants to be involved in creating solutions to community issues. To make sure that happens,

the Assembly is engaging in a robust public process to determine the best uses of the alcohol tax approved by the community in the April election."

Assembly Chair Rivera indicates that after the Town Halls, the Assembly plans additional time to review the feedback and then to finalize plans for uses of the alcohol tax. A work session is currently scheduled for **August 28**, **from 1pm - 2pm**, and Regular Assembly Meetings to hold public hearings and consider a formal resolution adopting a plan for uses of the alcohol tax are scheduled on **September 15 and 29**, **at 5pm**. Dates are subject to change based on feedback from the community and Assembly members.

The proposal for the Alcohol Tax was approved and placed on the ballot by the Assembly in AO 2019-148(S-1) As Amended, on January

28, 2020. At the April 7, 2020 Regular Municipal Election, Ballot Proposition 13, the Alcohol Tax, was approved by Anchorage voters.
