- Updates from ELC/CSM Programming meeting (Julie L):
  - 1. Please continue to spread the word that when discussing a PTA, it is Physical Thera**pist** Assistant. Also, when discussing physical therapy faculty, this includes all PTA faculty and DPT Faculty. If you are wanting to refer to one or the other, you need to specify it. This is a continual effort for consistency in language.
  - 2. Feedback and updates post ELC:
    - a. The SOE luncheon networking event was a hit.
    - b. The micro learns were well liked and likely hit the intention of providing brief content that can be applied immediately.
    - c. Next location is Kansas City. Usually have ideas for subsequent years by this time as well, but conference planning has become more difficult and they are trying to maintain low hotel prices for registrants.



- d. We should encourage or remind our membership to refer to the rubrics in detail when submitting abstracts for the conferences to help them score higher and have a better chance of getting their work accepted.
- e. Precons continue to be difficult to fill registration. Some ideas floating around to have smaller versions of these during conference time instead of requiring this ahead of the conference.
- f. We can now hold meetings at the same time as programming as long as there will be less than 40 (or it might be 50) people that will attend.
- 3. Webinars are continuing with goal of 7/year. Share any ideas with Steve or Michelle and remember this are peer reviewed (benefit for those with scholarship requirements in academia).
- 4. Continuing with the faculty development in person and virtual workshops, just finalizing date details.
- 5. The Educational certificate track is close to being able to be offered. There will be 2 phases for this certificate.
  - a. One for novice and the other one for more experienced individuals. They are looking for novices and experts to participate in the course to determine its effectiveness. They will also be looking for mentors who will be paid, who are subject matter experts.
- 6. Forward planning: How can we can engage students now that they are allowed a free AoE membership.
