Open Positions: Clinical Co-Chair (SCCE/CI)

1. The Co-Chairs shall develop the agenda and preside at all meetings, communicate with the APTA Academy of Education Executive Board, and oversee activities of the CESIG.
2. The Co-Chairs shall create and appoint all task forces and special advisory committees necessary to accomplish the functions of the CESIG.
3. The Co-Chairs shall submit an annual written report of the activities of the CESIG to the Section and participate in Executive Board meetings for the section.
4. The Co-Chairs shall be responsible for coordination of educational programming with the Section Programming chair.



Open Positions: Recording Secretary

1. The Recording Secretary shall be responsible for keeping and distributing the minutes of proceedings of all meetings. Policy and Procedure Manual Approved September 2022.
2. The Recording Secretary shall be responsible for all notices to members of the CESIG.
3. The Recording Secretary shall maintain records of all official actions of the CESIG
4. The Recording Secretary shall prepare an attendance roster for CESIG business meetings and distribute to the Co-Chairs.
5. The Recording Secretary shall prepare an orientation packet for new officers, including a roster of officers, standing rules for the CESIG and standing rules of the Academy.



Open Positions: Nominating Committee Member

1. Identify, in the spring, the SIG offices open for nominations in the upcoming election, communicating that information to the SIG liaison from the Academy Nominating Committee.
2. Recruit potential nominees in advance of position announcement(s).
3. Collaborate with the SIG liaison from the Academy Nominating Committee to initiate a call for nominations for open positions no later than two (2) months before the nomination deadline of November 1st.



Open Positions: Nominating Committee Member (cont'd)

4. Collaborate with the SIG liaison from the Academy Nominating Committee to ensure all required materials for respective SIG positions are submitted to the Executive office by the deadline of December 1st.

5. Review required SIG candidate materials (CV and consent to serve that includes a short bio and candidate statement) to select, when possible, at least two and no more than three qualified candidates for each office up for SIG election

- CSIF Rebranding late 2021. Rebranding of PT and PTA CPI January 3.
- Advisory board members sought feedback for content for newsletter.
- Proposed development of a tool to assist with guidance for students and CIs for categorizing “simple” and “complex” patients.

- Survey to explore current timeline for slot acceptance and slot cancellations from clinical education consortiums and academic programs
- Need CE SIG volunteers to help with:
 - survey development
 - survey deployment
 - survey analysis

Recommendation 3: “Provide professional training and development for Directors of Clinical Education and Site Coordinators of Clinical Education, especially those new to these positions.”
