Updates on Current Issues

CMS Regarding Medicare Provider Feedback on Therapy Services Section 230 - Practice of Physical Therapy, Occupational Therapy and Speech-Language Pathology, B. Therapy Students

In April, CMS solicited widespread feedback regarding the applicability of Part B reimbursement rules to the Part A inpatient hospital, rehab and SNF environments. Of specific interest to the CESIG, was the section outlining billing and reimbursement of student provided services. Based on the input we received from several ACCE/DCEs, we sent the following statement to CMS:

"Given our personal experience with physical therapy students and those of our colleagues in inpatient hospitals and inpatient rehab facilities, Part B rules for the billing for the provision of services by students are inappropriate for inpatient hospital Part A settings. Therapy services provided to patients in inpatient hospital and inpatient rehabilitation facilities are reimbursed through payment to the hospital based on a DRG or PPS system, regardless of the amount of therapy received. The hospital is reimbursed for care of the patient regardless if therapy is provided or how much is provided. It would be most reasonable for services provided by physical therapy students to be supervised by a qualified practitioner under direct supervision as defined by the American Physical Therapy Association as the supervising therapist being physically present and immediately available for direction and supervision."

Medicare Debate Heats Up - A Forecast for Action

With the clock ticking on the expiration of key Medicare provisions, Congress begins to put its legislative proposal together. The House-passed Medicare bill from last summer, the Children's Health and Medicare Protections Act (CHAMP) (HR 3162) is still active. This legislation was an extensive legislative package and was unable to pass in a tightly controlled Democratic Senate, leading to the compromised short-term fix at the end of 2007, the sCHIP, Medicare and Medicaid Extensions Act (S. 2499). S. 2499 provided six-month extensions on critical priorities for physical therapists, including a .5% update in the conversion factor of the Medicare physician fee schedule, an extension of the therapy cap exceptions process, and rural payment updates. One provision was a permanent fix to hold the admissions criteria threshold for inpatient rehabilitation facilities (IRFs) at 60%, thus changing the old "75% rule" to the "60% rule." With the House sticking to their passed CHAMP legislation, the first move on a 2008 Medicare bill will be in the US Senate. To address the expiring provisions by the June 30, 2008 deadline, the Senate Finance Committee has begun to develop its legislative package. They have been negotiating the package directly with the Administration and the US House of Representatives to ensure that the legislation can pass and be signed into law in an expedited manner to avoid disastrous cuts to Medicare providers and the patients they serve. Recent reports indicate that the Senate will move its legislation directly to the US Senate floor in mid May with hopes of passage and signature by the President before June 30th. Although the details have not been released the package is likely to include an 18month extension to the therapy cap exceptions process, a freeze or .5% update to the conversion factor under the Medicare provider fee schedule. Without Congressional action by July 1st, providers will be subject to a 10.1% cut in payments under the MPFS and patients will be subject to an \$1810 cap to their combined outpatient physical therapy and speech language pathology services provided in all settings but the hospital outpatient department. Your advocacy on these issues continues to be essential as we move closer to the pending deadline and Congress begins to debate Medicare.

House Approves One Tuition Forgiveness Program

Physical therapists (PTs) who choose to work with children, adolescents, or veterans would be eligible to apply for student loan forgiveness under legislation recently approved by the US House. Meanwhile, a current federal program is accepting applications for loan forgiveness from qualifying PTs who agree to practice in Indian Health Service (IHS) settings. Rep Joe Sestak (D-PA) on February 7 introduced an amendment to the College Opportunity and Affordability Act of 2007 (HR 4137) that would authorize the US Secretary of Education to forgive a portion of qualifying student loan debt to PTs practicing in areas of national need. Members of the House and Senate will meet in conference to finalize the legislation. In addition, the IHS Loan Repayment Program, which already exists under federal law, is accepting applications from qualifying PTs. Applicants who agree to serve for 2 years at an IHS facility or under an approved health program are eligible for more than \$22,000 per year in tuition repayment.
