#### **Updates on Current Issues**

## CMS Regarding Medicare Provider Feedback on therapy services Section 230 - Practice of Physical Therapy, Occupational Therapy ans Speech-Language Pathology, B. Therapy Students

Last year, CMS solicited widespread feedback regarding the applicability of Part B reimbursement rules to the Part A inpatient hospital, rehab and SNF environments. Of specific interest to the CESIG, was the section outlining billing and reimbursement of student provided services. The CESIG leadership disseminated a survey for feedback. No updates or changes in the current status of the Medicare regulations have taken effect. If we become aware of any updates, we will be in contact with membership.

## Physical Therapy Clinical Education Voluntary Uniform Mailing Date Survey

#### Background

At the February 1998 CESIG meeting, both the Department of Education and the CESIG presented data from surveys of ACCEs and CCCEs. There was a discussion regarding the condition of clinical education and ways of easing the load for the CCCE. A motion was made to consider the concept of a voluntary uniform mailing date for requesting clinical slots. The motion included mailing dates of January 1 through January 15, the preferred dates noted in a poll conducted by the APTA Division of Education. Discussion indicated some schools might have difficulty with those dates, as many schools are not in session during that time and a window of dates could not be agreed to. The motion containing the January dates was defeated. A second motion was made "that we

voluntarily agree to a date for a national mailing request for sites by PT and PTA programs". That motion was deferred until the Scientific Meeting and Exposition in June 1998. Clinical educators in the room were encouraged to return to their consortia, clinical facilities and academic program and discuss the motion. The group recognized the impact of establishing a set of voluntary mailing dates and understood that significant compromises would be necessary in order for all programs to eventually accept the dates.

At the June 1998 CESIG business meeting in Orlando, clinical education representatives from across the country reported widespread acceptance of the concept of a uniform mailing date. The motion deferred from the February meeting "that we voluntarily agree to a date for a national mailing request for sites by PT and PTA programs" was passed unanimously. Further, there was a unanimous agreement that the voluntary national mail-out date be between March 1 and 15 with a requested return date of April 30, and that the requests for slots be for the following calendar year only. The voluntary uniform mail-out date was implemented in 1999.

We received a significant amount of feedback indicating many programs are not complying with the March mailing dates for various reasons, sending requests out much earlier in the calendar year. Thus an ANONYMOUS survey at the following link: http://www.surveymonkey.com/s.aspx?sm=4ptK C8M4tplEbmtRyvAoWw 3d 3d was mailed to membership and forwarded to CCCE's and CI's across the country for feedback regarding the current status of the Voluntary Uniform Mail-Out Date. We are collecting results currently and we hope to use the results of this survey to revisit the utility of the issue.

## Topic: Update and information regarding development of new PT Education Organization

Information regarding the development of the new PT Education Organization was shared at the CESIG meeting in Las Vegas in February and e-mailed personally to CESIG members and DCE/ACCE's at PT and PTA programs in late March 2009. Some e-mails were secure and could not receive the message. Below is a summary of the information and e-mail.

As the current ACCE/DCE Co-Chair of the Education Section Clinical Education Special Interest Group, Alecia Thiele has over the past couple months had the privilege of being a

member of a working group charged by the AASIG to explore and facilitate the development of a new organization that will replace the AASIG and serve as the collective voice of academic physical therapy programs. The group consists of individuals that represent the range of PT programs around the country. The group includes program directors from small and large programs, private and public institutions, the north and south, and east and west as well as a representative from the CESIG and PTASIG.

The committee presented a proposed mission, vision, and goal statements at the recent AASIG, CESIG and PTASIG and AFSIG business meetings in Las Vegas. The committee would like to move forward with the ratification of the organization's bylaws at this year's Educational Leadership Conference in October, with the intent of having the organization operational as of January 1, 2010.

With this goal in mind, the committee is asking for your input and support. The committee has laid the groundwork, and now it is time for our larger community to provide feedback and help us form an organization that will best serve our mutual needs. The committee urges you to review the information, discuss it with your program chair and faculty, and forward this information onto your clinical constituents (CCCE's and CI's) as well.

There will be additional opportunities for discussion of the bylaws and all aspects of the organization at the Annual Conference in Baltimore this June and considerable time will be set aside at the ELC in October. Alecia Thiele would be happy to discuss any aspect of the proposal with you or other members of your faculty, and would really appreciate any feedback that you may have regarding the proposed organization. Your program chair has been contacted with this information. He/she has been asked to share this information with his/her DCE/ACCEs so we can assure a strong bond between academic and clinical education. The committee is again asking you to share this information with your clinical constituents as well (CCCE's and CI's) to be certain to include your clinical faculty.

Please know, absolutely nothing is carved in stone; the committee is even flexible regarding the name of the organization. What is important to all of us is that this organization serves the needs of PT programs across the country to foster excellence in all that we do. ## Update from the Department of Academic/Clinical Education Affairs – May 2009

- Clinical Instructor Education and Credentialing Programs
  - Advanced CI Education and Credentialing Program (Advanced CIECP). The Advanced CIECP was launched January 2008 with the goal of facilitating the CIs ability to provide best clinical teaching and best clinical practice in managing students. This program is available APTA Credential CIs who are licensed PTs in the United States and Canada and have supervised, mentored, or taught at least one student since earning their CI Credential. Currently, there are 49 Advanced Credentialed Trainers available to teach the Advanced CIECP and 319 Advanced Credentialed CIs. To access information about this program, click here.
  - Clinical Instructor Education and Credentialing Program (CIECP): The CIECP has credentialed nearly 25,000 physical therapist and physical therapist assistant CIs in the United States and Canada since the program's inception in 1997. In addition, 2008 was a remarkable year with 180 courses provided by 169 Credentialed Trainers throughout the US and in Canada, resulting in the credentialing of more than 3,800 clinical educators in one year.   and Credentialing Program and are
  pending review.
- APTA recognizes, values, and promotes organizations that meet the challenge of having 100% of their designated clinical instructors (CIs) successfully complete the APTA CIECP. Organizations receiving this award are provided with a voucher, at the member rate, for one of their APTA Credentialed CIs to attend the Advanced CIECP. For more information about this competition, please click here. The next application deadline for the 100% Credentialed Clinical Instructor Competition is June 30, 2009 and can be accessed here.
- **Physical Therapist Clinical Performance Instrument (PT CPI):** The APTA PT CPI ( Version 2006) was launched July 15, 2008 in a Web-based version by Academic Management Systems, Inc. (AMS), a subsidiary of Liaison International, in collaboration with APTA, using the company's market-leading assessment product-CoursEval<sup>TM</sup> as the underlying technology platform. AMS, provides to physical therapist programs registered to use the PT CPI Web, training and technical customer service. To date, 152 physical therapist academic programs are registered with AMS to use PT CPI Web of which 97 programs have entered their information in the system. All users of the PT CPI Web must complete the PT CPI online training and assessment program (free) prior to being able to access to the PT CPI Web. More than 14,500 users have successfully completed the PT CPI online training and assessment program that transitioned to the APTA Learning Center on January 26, 2009. A set of Directions for Use for accessing the PT CPI online training and assessment are available to all users through AMS, academic programs, and APTA. - **Physical Therapist Assistant Clinical Performance Instrument (PTA CPI):** Similar to the process used to revise the PT CPI, the PTA CPI is currently undergoing its first major revision following a similar redesign and testing process using an online training component and electronic format of the instrument. The final version of the PTA CPI field-testing will be completed by May 31, 2009. Results of the fieldtesting will be analyzed to determine the instrument's validity and user satisfaction. The PTA CPI will subsequently undergo similar development in preparation for its implementation using an online training and assessment program and the development of a web-based PTA CPI. A PT '09 presentation is scheduled for Friday, June 12, 2009 from 2:00 – 3:30 pm on "Preparing to Use the Web-Based PTA CPI".
- **Draft Outcomes from Clinical Education Standards Conference and Regional Forums:** Draft outcome clinical education standards from the December 2007 consensus conference on clinical education were completed and made available on the APTA website. In 2008-2009, thus far 9 of 14 regional forums have been convened throughout the United States. Five regional forums remain that are scheduled in Portland, St Louis, Newark, Dallas, and Denver. These regional forums are available to both invited participants and individuals interested in physical therapist clinical education from broad stakeholder groups including physical therapist academic and clinical educators, clinicians, managers, employers, clinical residency/fellowship faculty, and students. These forums provide time to discuss and refine the draft consensus-based clinical education standards that are used as a springboard for discussion. Participants suggest opportunities and resistances to achieving outcomes associated with clinical education standards and a preferred organization and delivery of clinical education, remedies for implementation, and next steps based on the results of a larger consensus on

- standards in clinical education. A report is planned for the 2009 November Board of Directors meeting. An update on the status of these regional forums is scheduled for PT '09 on June 12, 2009 from 3:30 5:00 pm.
- Professionalism Modules: Three online modules on Professionalism were launched in 2008 through the APTA Learning Center. These modules provide an Introduction to Professionalism, History of Professionalism in Physical Therapy, and Ethical Compass. These modules are free to members and prerequisite to completing the Advanced CI Education and Credentialing Program and can be accessed here. To date, approximately 1,200 persons completed Module 1 -Introduction to Professionalism, 1,030 completed Module 2 – History of Professionalism in Physical Therapy, and 885 completed Module 3 – Ethical Compass. Four additional modules are in development for 2009.

#### ACCE/DCE Performance Aggaggment: An Ad Hag Ad

**Assessment:** An Ad Hoc ACCE/DCE Performance Assessment Group has been working on *voluntary* ACCE/DCE performance assessments for physical therapist and physical therapist assistant programs. This initiative was undertaken in response to requests from some physical therapist and physical therapist assistant programs for an evaluation mechanism in support of the roles and functions of the ACCE/DCE. Performance assessments have been developed to be completed by multiple stakeholders including students, CIs/CCCEs, faculty, and Program Directors/ACCE/DCEs. The Ad Hoc group will be reviewing feedback on the second draft versions of these *voluntary* assessments in preparation for creating final ACCE/DCE performance assessments to be tested for functionality and user satisfaction. The Ad Hoc Group will be inviting interested ACCEs/DCEs from physical therapist and physical therapist assistant programs to volunteer to test these performance tools in the fall with the

varied users to determine their usefulness and overall satisfaction.

**DPT Transition Programs**. As of October 2008, post-professional DPT (transition) degree programs report that since 1999, an estimated 20,013 students have been or currently are enrolled in t-DPT programs of which 10,543 have graduated and or are anticipated to graduate in 2008-2009. Since 2006-2007, programs have reported a declining trend for new admissions into these programs. For 67.2% of these programs, the minimum degree required for acceptance into a DPT (Transition) program is a bachelor's degree in physical therapy with 89.7% requiring US PT licensure.

#### • <u>Consultant Group on</u> <u>Interprofessional Professionalism:</u>

APTA is facilitating a long-term interprofessional collaborative initiative to develop a "tool kit" on interprofessional professionalism to include mechanisms to assess interprofessional professionalism. Members of this group represent AAMC, ADEA, AACP, APA, ASHA, NBME, AACOM, AACN, ASCO, and APTA. In 2008-2009, the Consultant Group on Interprofessional Professionalism provided panel presentations with participant interaction on a set of draft entry-level behaviors, values, and attitudes that reflect interprofessional professionalism to each of the representative professions at their respective national conferences and at the 13th Annual Ottawa Conference in Melbourne, Australia. In addition, an Interprofessional Professionalism WIKI page (http://ippmg.pbwiki.com) was developed to facilitate interprofessional communication and feedback about this topic.

On April 22, 2009, a presentation was provided to the Advisory Committee on Interdisciplinary, Community-Based Linkages (ACICBL).on the work of the Consultant Group including opportunities, best practices, and recommendations specific to interprofessional work as a core

competency for quality. Several presentations were made to the members of ACICBL, an appointed group of the US Department of Health and Human Services, Health Resources and Services Administration, Bureau of Health Professions, in preparation for a 2009 report to Congress that will address: "Toward Quality Healthcare Reform: Preparing the Interprofessional Healthcare Workforce for Primary Care".

#### **Government Affairs**

Legislative Update (May 4, 2009)

By the time this newsletter is released, the APTA Annual Government Affairs Forum will have taken place in Washington, DC as therapists across the country will be visiting with their elected officials. Thus, it is likely that additional co-sponsors will be added. Please check the Legislative Action Center on the APTA website for the current status. You can also check the official posting of cosponsors using this link: http://thomas.loc.gov/ Type in the bill number under the heading 'Search Bill Summary & Status' (example: HR 43) and click on bill number option below the blank.

The APTA has been busy working with sponsors to introduce bills during this session:

#### 1. Therapy Cap (HR 43/S. 46) -

Legislation to repeal the 1997 therapy cap legislation on therapy services for Medicare beneficiaries. We have 67 cosponsors and expect a big boost of cosponsors after the May 17-19, 2009 Forum.

Latest update: The House passed a conference budget agreement on 4/28/09. This is the first step in the process of getting the therapy cap addressed. We were able to secure language in the Senate budget which was then accepted in the House/Senate conference. Senate budget language directs committees of jurisdiction to include therapy cap language as they draft their bills in the coming weeks.

This is our first victory on the therapy cap and the only 2 healthcare provisions included were physician fee schedule fix and therapy cap. We expect the House/Senate budget will include therapy language which will be a key start in getting the therapy cap addressed before the exceptions process expires at the end of the year. Our goal is to **repeal** the cap. There is also work going on at CMS to develop short/long term alternatives to the therapy cap.

- 2. **Direct Access (HR 1829/S. 950)** the Medicare Patient Access to Physical Therapists Act. The Senate version (S.950) of legislation was introduced late on Thursday, April 30<sup>th</sup> by Senators Blanche Lincoln (D-AR), Lindsay Graham (R-SC), and Arlen Specter (D-PA). The House version, HR 1829, was introduced on March 31 by Earl Pomeroy (D-ND) and currently has 61 cosponsors.
- 3. HR 988, the "Physical Therapist Student Loan Repayment Eligibility Act" enables physical therapists to participate in the National Health Service Corps (NHSC) Loan Repayment Program. It allows PTs with active federal student loans to receive up to 50k in loans for 2yrs of service in underserved areas. We have 41 cosponsors presently. The Senate version of this bill may be introduced shortly. We are finalizing our Republican lead on this bill in the Senate alongside Senator Tester (D-MT). This legislation will be important in upcoming health care reform because

of numerous workforce initiatives in healthcare reform and expansion of NHSC is on the table.
