APTA members can download the document for FREE. To purchase a hardcopy, the cost is \$9.00 for members, and \$15.00 for non-members. Thanks to Patty Trela, Debbie Ingram, and everyone else who had a hand in putting this document together.

**Grants Funded.** In compliance with motion RC 36A/C, passed by APTA's 2001 House of Delegates, the APTA has funded two contracts to investigate alternative models of PT professional education:

- Massachusetts General Hospital Institute of Health Professions, Boston, under the principal investigators Leslie Portney, PT, PhD, FAPTA, and Mary Knabb, PT, MS, DCE will investigate an internship model of clinical education.
- 2) Nova Southeastern University, Ft. Lauderdale, FL, under principal investigators Shari Rone-Adams, PT, MS, GCS, and Debra F. Stern, PT, MSM will study the hybrid model of clinical education.

An interim report on the status of these investigations will be provided to the House of Delegates in June 2003 with a final report in June 2004. Congratulations to these recipients!

Debbie Ingram surveyed the members of the Education Section regarding their opinions of **11 Federal Government Affairs Critical Issues.** This request was electronically sent to all Education Section Board members, and was also posted on the Education Section listserv. Twenty-one respondents ranked these issues in order of their perceived importance, with #1 being most important. The result is as follows:

- 1) Physician Status Under Medicare for PTs (Medicare Direct Access)
- 2) \$1500 Therapy Cap-Repeal and Alternative Payment System
- 3) Medicare Supervision Policies (including 30-day recert. requirements)
- 4) Federal Funding for Clinical Education and Research
- 5) Stark II Regulation (opposing physician self-referral)
- Medicare Clinical Coverage issues
- 7) Legislation to Provide Patient Protection in Managed Care
- 8) Medicare Coding Policies (coding initiatives, 8-minute rule and group therapy)
- 9) CMS Reform
- 10) Programs for Children with Disabilities
- 11) Health Insurance Portability and Accessibility Act (HIPAA)
