Debbie Ingram, PT, EdD has graciously continued to be our advocate and representative in the area of government affairs. Please read her updated information below following her return from "the hill" earlier this spring.

The APTA is continuing to advocate for improved access to PT under Medicare and the re-authorization of IDEA. Please help with these efforts. It's really easy! All you have to do is go to the APTA web site and click! Here is the address: http://capwiz.com/amerpta/home/ What do you need to know about Direct Access under Medicare? This legislation currently has the bipartisan support of more than 138 members of the US House of Representatives and 13 Members of the US Senate. Request your Members' co-sponsorship of the Medicare Patient Access to Physical Therapy Act (HR 792/S.493) to improve accessibility to outpatient physical therapy services under Medicare as

authorized by state law. Currently, 48 states allow direct patient access to physical therapist evaluation and 39 allow treatment following the evaluation. It is time that Medicare offer beneficiaries the same access to physical therapists that non-Medicare patients in these states enjoy. Direct access has proven to be cost-effective, maintain patient safety, and put beneficiaries in control of deciding who provides their rehabilitation care. Various patient and provider groups, including National Rural Health Association and the Brain Injury Association of America, support this legislation. If your Member of Congress is already a cosponsor, be sure to thank them for their support. If your Member of Congress is not a cosponsor, request that they cosponsor HR 792 or S. 493 today.

What do you need to know about IDEA? The re-authorization of the Individuals with Disabilities Education Act was passed by the US House of Representatives last year. It is now with the US Senate and should be debated in early May. APTA supports efforts to improve federal funding levels for this program and to assure that related services are provided by qualified personnel. PT is a related service under IDEA and only licensed physical therapists are qualified to deliver PT to the children with disabilities served by this program.

We are excited to continue networking with all of you whether it is at national meetings, state chapter meetings or via email or phone. We hope you all received the email encouraging each of us to spread the energy of this group to encourage more members in the Education Section and also the Clinical Education SIG. The Sections membership is down 5%. The following objectives can provide topics for discussion and interest in the promotion of education:

- 1. To provide a vehicle for increasing and improving communication among clinical educators.
- 2. To increase the participation of clinical educator in the Education Sections.

- 3. To provide continuing education in areas pertinent to clinical evaluation and teaching
- 4. To foster problem solving in clinical education using the scientific method.
- 5. To promote cooperative efforts among educational programs and clinical sites in scheduling, evaluation, and continuing education.
- 6. To develop guidelines for the continuing development and evaluation of academic and clinical faculty involved in clinical education.
- 7. To serve as a resource body involved in acquiring, cataloguing, and disseminating information relating to clinical education in physical therapy.
