Invited speakers:

- Kendra Harrington- ABPTRFE
 - o Breakdown of number of residencies/fellowships
 - > Data from 2013-2017: 264 accredited residencies; 54 accredited fellowships
 - Newly accredited residencies:
 - Performing Arts
 - > Oncology
 - o 88 current applications
 - ➢ 61 initial accreditation (20 in developing status/41 in candidate status)
 - ➢ 22 reaccreditation
 - Upcoming initial accreditation Track:
 - September 2020 Track: 32 new programs entering accreditation
 - ➢ January 2021 Track: 1 program
 - Site visits:
 - > 2018: 66 total; 3 site visits left
 - > 2019: 76 site visits, but may modify

- Staffing:
 - Fenos Judd was hired for his technology skill set and residency knowledge to design management system; Goal: By end of year 100% applications through management system
 - Stephanie McNally left this year; ABPTRFE then reassessed her position/job duties Job title is now: Lead specialist position
 - Seeking candidates for position (5+ years of experience)
 - Posted on APTA job website
- Update on Residency Competency Assessment:
 - 7 core competencies created with core list of behaviors demonstrated to meet competencies; resident/mentor evaluation forms created and psychometric study currently underway
 - September 17, 2018: collection concluded;
 - > Next step: statistician to determine validity and reliability of data collected

477 mentors, 422 residents participated in study:

464 evaluations completed by mentors,

366 evaluations completed by residents

- Update on Accreditation Management system:
 - Launched Feb 2018
 - > Programs will now use this tool for accreditation and re-accreditation
 - ▶ Integrating PayPal launch to begin December 1, 2018
 - > Every program will be submitting annual report into new system
- External Consultant: external audit for past two years;
 - > June 2018 ABPTRFE adopted new standards, policies/procedures, fee structure
 - Kendra developed presentation regarding information. Will repost presentation on website after current overhaul of website
 - Currently posted in Residency/Fellowship Hub community
- Quarterly program director newsletter:
 - Plans to house older issues in Hub community;
 - Next newsletter: October
- SIG Chair committee created:
 - First meeting: CSM 2018. Purpose: discuss issues that various groups are experiencing.
 - Plans to meet 3x/year (one at CSM: two virtual)

 - Therapy cap is repealed
 - Sports Medicine Licensure clarity act- liability will travel with you
 - (PT license does not travel from state to state, since this is a state issue, not a federal issue);
 - PTA's included in Tricare coverage
- Upcoming issues:
 - Prosper Act- if passed,
 - 1. PT students will be limited in eligibility to receive loans- will be capped at less than \$29,000/year);
 - 2. Accreditation bodies (such as ABPTRFE) can in no way be associated with the overarching body of the profession (in our case, APTA)
 - 3. The APTA knows about this Prosper Act because of PT-PAC's donations to those who work to identify issues relevant to our profession

 - Accreditation Management system is live now for re-accreditation on the ABPTRFE Website
 - 2016 and 2017 Annual Residency Fellowship reports posted on website
 - ELP added 2 non-voting members to their board. One from ABPTRFE and one from ABPTS (American board of PT specialists)
 - Several areas on new practice: Concussion Management Fellowship, Sport Performance Fellowship, Endurance Athlete Fellowship, Neurologic Movement Disorders Fellowship

- **HUB** Christina Gomez
 - Assessed audience knowledge on how to access Hub communities webpage
 Sara Kraft gave demonstration for audience
 - Currently some resources different on website and RFESIG Hub community
 - All are welcome to independently post in forum to start discussions/engage each other
- Think Tank Carol Jo Tichenor
 - 2 years ago- survey of SIG programs:
 - > What areas of curriculum would programs like more feedback?
 - > What resources are programs willing to share with others?
 - > Results of survey demonstrated a need in the following topics:
 - Ethics
 - EBP
 - Statistics
 - Mentor training/assessment
 - Mentor/resident prep/training forms
 - Technology
 - Think Tank has been collecting resources since February, 2018 on the above topics
 - 23 reviewers- assessed resources and interviewed programs
 - Also looking at APTA Learning Center, Independent Study Courses available

- Carol Jo recognized the efforts of all reviewers: 4 were present- Lauren Snow, Jim Moore, Dave Nolan, Tara Dickson
- Currently in negotiations for platform to bring resources to community
 - ➢ Goal is to have documents available by CSM
 - > Deadline for first phase of residency/fellowship resource submissions:
 - November 5, 2018
 - Please email Carol Jo at caroljot@gmail.com
 - Sara stated that goal is for this to be ongoing process to accept innovative resources so all residencies/fellowships can benefit from sharing of curriculum
 - Format of material desired is open
 - Examples of current submissions: PowerPoint, resident/fellow development forms, mentor training forms
 - If a program would like to share resources, please submit resource in preferred format and discuss how it is used in their program.
 - If anyone finds learning modules on internet or other reference, Think Tank would also like those.

- Excellence in Mentoring Award Sara Kraft
 - Residency/Fellowship Education Award has been approved by APTE
 - ➢ First award will be presented in 2020
 - > 2019- Call for nominations
 - From Kendra:
 - > Be on the lookout to nominate a person for Outstanding Resident or Fellow-in-training Award
 - Awarded by ABPTRFE
 - Thank you to John DeWitt for the idea of the awards
 - > John- Acknowledged the hard work behind these awards
- Research Committee Sara Kraft
 - Created work group with people from different cohorts to look at residency/fellowship education research
 Meeting scheduled for tonight
 - Questions posed to audience:
 - What questions do we have?
 - ➤ What do we need to prioritize?
 - Response:
 - Other ways to characterize success from residency other than graduation and board certification
 - Need for multi-site collaboration to collect enough data to be meaningful

- What requirements needed to be qualified to become faculty?
 - How do we show value in residency/fellowship training?
 - A few residencies looking at clinically meaningful changes per patient encounter
 - Could we measure how we motivationally interview/interact with patients?
- What characteristics do residents have that allow them to succeed in residency programs?
 - Need to define measures of success
 - Current study going on looking at motivation level and lifelong learning

• Q &A from floor

- What are the requirements for residency before fellowship education?
 - Response from Kendra: Residency or Board certification
- Will ABPTRFE be assessing resident/fellow/program outcomes with new database system?
 - Response from Kendra: new annual report/accreditation system requires R/F programs to establish their own resident/fellow goals; they then must explain each year how they are meeting these goals
- Can new Residency Competency Assessment tool be used to collect data to compare performance of graduates and non-graduates of post-professional training?
 - Response from Kendra: data will be collected but will take a few years to consolidate and analyze
- New research assessing residency program characteristics and their outcomes on resident graduation rates and which residents choose to sit for board specialty exam?
 - They noted previously published literature in medicine and veterinary medicine (outcome measures commonly used are exam pass rates, safety, error rate, economic aspects to residency, subspecialty outcomes)
- Carol Jo- Do any of you have a system looking at patient satisfaction in clinicians who were residencytrained versus non-residency trained?
 - Current difficulties in using patient satisfaction for an outcome measure are low patient response rates and similar patient surveys across facilities
