### **Update from APTA**

Kendra Harrington: RF Education

- Main communication network on APTA is the RF HUB Community page: if not signed up for alerts please sign up or contact Kendra for info on how to do so
- 2019
  - Candidacy and Accreditation workshops on learning center and Follow up webinars for program directors
  - Residency Competencies workgroup: validation study of the evaluation form is complete and awaiting editing for publishing.
    - Goal is to host the document electronically on APTA website and free of charge to programs by the end of February.
  - November: validation or revalidation of 7 practice areas. Acute Care, Critical Care, Movement Systems, Spine, Sports Conditions I, Neonatology, Higher Education Leadership
    - Practice analysis surveys coming soon
- 2020
  - Overhaul site visit process

- Open up the call for site visitors: 1 public member will also be on the team
- APTA mentoring workgroup: look at data and research and update the mentor resource handbook and standardize mentorship validation tools
- CCIP (Credentialed Clinical Instructor Program) meeting: brainstorming about Level 3 and possibly adding a mentoring component to that credential
- Expansion of Residency Competencies (DSP): next phase to develop specialty specific standardized skills assessment

#### Ryan Bannister: RF PTCAS, PTCAS, PTACAS

- RF PTCAS annual applicant data report coming March this year: aggregate data report of pool of applicant data
- A similar report is done for DPT program applicant data and acceptance but the information cannot be pulled out for acceptance in RF programs if directors do not say who has been accepted into their programs.

  - Minimum of 105 scheduled for 2020
- Substantive Change policy 13.4.2: public comment period: will be posted in the coming weeks
- Minor updates for ABPTS Processes and procedures:
  - 2.1.2: participant enrollment has changed locations and is no longer in the application for candidacy
  - 4.2: renewal for accreditation notification. Site visitors will need a revised and updated practice site chart and information on hotel reservation prior to arrival
  - 6.3.4: denied initial or withdraw accreditation: language added to clarify what would be appealable action

- 7.2: deferred accreditation: will be posted and publicly disclosed
- 10.0: maintaining accreditation: location moved and is no longer under application for candidacy
