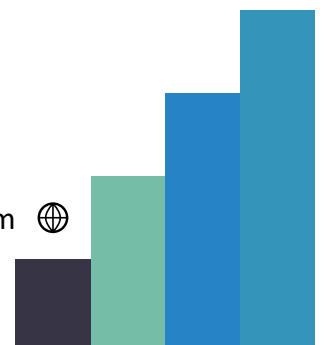
### **Signature Bank of Georgia Recognizes Q1 2024 Mover & Shaker Winners**
