Community Bankers Association of Georgia (CBA) and the Walraven family announce an annual scholarship through the **J. Steven Walraven Memorial Scholarship Fund** to a full or part-time Georgia community bank employee planning to attend or currently enrolled in a college, university or technical institute within the state of Georgia. The goal of the scholarship is to assist those employees interested in furthering their education while enhancing their career in community banking. To compete, employees must write a short essay on how community banking has impacted their life and how it will enable them to give back to their community.

The scholarship is named after the late **J. Steven Walraven**, a former community bank president who dedicated much of his life to his community and community banking. His wife Rebecca and their sons have developed the scholarship in his memory.



Steve was a graduate of Reinhardt College and University of Wisconsin School of Banking. He began his banking career at the First National Bank of Atlanta. He worked for Gordon County Bank and Bartow County Bank and became president of Peoples Bank in 1981. In 1988, he helped form First Community Bank & Trust, Cartersville, serving as president. In 1999, he was named president of United Bank & Trust in Rockmart.

Steve was a member of the Board of Directors of Community Bankers Association of Georgia and served as Treasurer.

 Open to full or part-time employees of Georgia community banks desiring to continue their education at a Georgia college, university or technical institute in the fall quarter or semester of 2024 (scholarship will be awarded to another applicant if program is not started in that quarter/semester). Scholarship winners will be announced in the Spring of 2024.

2. Qualifications:

- Complete application
- Prepare essay on how community banking has impacted your life and how it has enabled you to give back to your community
- Must be an employee of the bank for at least one year
- Recommendation from the President/CEO of applicant's bank
- Award based on merit, involvement in the community and need
- 3. At least one \$500.00 scholarship funded by the **J. Steven Walraven Memorial Scholarship Fund** is awarded.
- 4. Scholarship remitted to the college, university or technical institute by the Community Bankers Association of Georgia (CBA) to an account in the student's name to be applied toward tuition, books and expenses.
- 5. All winning or selected applicants from each community bank will be forwarded to the CBA office for review and judging.
- A Judging Committee of CBA member banks and Associate Member companies will meet and determine the scholarship recipient. A notice of the applicant chosen will be mailed to the sponsoring bank president, who will notify the applicant selected.
- 7. Any award not utilized may, at the Committee's discretion, be used to increase the number of awards for the next year or the scholarship may be awarded to one of the semifinalists.
