



ACT Submits Comments on Interim CMAQ Guidance



PUBLIC COMMENTS

Earlier this month, ACT submitted [public comments](#) to the recently released interim CMAQ guidance from the Federal Highway Administration. ACT urged the FHWA to provide further clarification on the eligibility to receive funding for incentive-based TDM strategies. This would include clearly stating broad-based programs which would qualify, such as telework promotion, flexible work hours, commuter benefits, and integrated mobility hubs that combine shared micromobility, transit access, and parking management.

As CMAQ guidance is critical for the dispersion of funds for TDM programs, ACT strongly believes in bolstering this guidance. TDM practices lead to more efficient modes of transportation, cleaner air, less congestion, and a strong economy. With uncertainty ahead on the future of CMAQ guidance with the incoming Trump Administration, ACT believes it is imperative to set formidable standard for guidance going forward.
