Cleared for takeoff: FAA Reauthorization



All signs from Congressional leadership, as well as advocacy and industry groups, point to an FAA reauthorization deal being reached by the May 10 deadline. Congress previously extended this deadline in March to allow for more time to reconcile the differences between the House and Senate versions of FAA reauthorization legislation.

It remains uncertain whether the TDM provision in the FAA reauthorization bill has been included in the final bill. ACT has submitted a letter to the Chairs and Ranking Members of the House Committee on Transportation and Infrastructure and the Senate Committee on Commerce, Science, and Transportation urging the inclusion of the TDM provision, which can be found <u>here</u>.

Funding Opportunity: Congestion Relief Program



As a reminder, the <u>Congestion Relief Program</u> is still accepting applications for grants, which will total up to \$150 million. Eligible candidates include MPOs, municipalities, states, and cities with a population of over one million. This program aims to support projects in urban areas that combat congestion and its related environmental and economic effects It also seeks to strengthen the efficiency of existing infrastructure and encourage travelers to use forms of transportation other than single occupancy vehicles.

Applications are due by Monday, April 22, 2024.
