



Practice Exam

This 20-question practice exam aims to provide candidates for the TDM-CP exam with a general understanding of the types of questions and content that may appear on the official exam. The practice exam may serve as a tool to help determine if you are properly prepared for the exam. Please know that these questions may have appeared on previous exam forms but were eliminated or were never approved by the Exam Committee for use in the TDM-CP exam due to item performance, duplication of concept, or other various reasons. For the TDM-CP exam, you have 180 minutes to answer 120 questions. To reflect the same pace for the practice exams, you should allocate no more than 30 minutes of time to answer all 20 questions.
