

## **CDE and California Department of Social Services (CDSS) Joint Guidance to State Subsidized Early Learning and Care (ELC) Programs and Child Care and Development**

In accordance with the California Budget Act of Fiscal Year (FY) 2020–21, effective July 1, 2021, all General Child Care and Development Programs (CCTR); California Family Child Care Home Education Networks (CFCC); Programs for Children with Severe Disabilities (CHAN); Migrant Child Care and Development Programs (CMIG); Migrant Child Care Alternative Payment Programs (CMAP); California Alternative Payment Programs (CAPP); CalWORKs Stage 2 (C2AP); CalWORKs Stage 3 (C3AP), Resource and Referral Programs (CRRP), and Local Child Care and Development Planning Councils (CLPC) will transfer to the California Department of Social Services (CDSS), Child Care and Development Division (CCDD).

The CDE, ELCD, will continue to administer the California State Preschool Program (CSPP), the Inclusive Early Education Expansion Program (IEEEP), the Early Head Start Child Care Partnership grant awarded to the CDE by the U.S. Department of Health and Human Services, as well as other early education programs.

Throughout the month of June 2021, the CDE, ELCD, and the CDSS, CCDD will be issuing joint guidance to state subsidized ELC programs regarding this transition. The CDE, ELCD and the CDSS, CCDD understand that this transition has a substantial impact on ELC programs and we are working collaboratively to mitigate administrative burden for contractors, to the extent possible.

For FY 2021–22, contractors for both the CDE and the CDSS will continue to adhere to the following contract requirements:

### **Funding Terms and Conditions and Program Requirements**

### **12 Month Eligibility**

## **CDE and California Department of Social Services (CDSS) Joint Guidance to State Subsidized Early Learning and Care (ELC) Programs and Child Care and Development**

- Management Bulletin 17-14, which provided interim guidance on 12-month eligibility, will be rescinded and no longer in effect as of July 1, 2021.

### **Licensing Requirements**

- Unless exempt from licensure, **all** center-based programs and family childcare homes are required to maintain a facility license issued by the CDSS, Community Care Licensing Division (CCLD).

### **Contracts**

- The CDE and the CDSS have worked together to minimize disruption to the field as a result of ELC programs transferring to the CDSS on July 1, 2021. As such, the CDE will be issuing initial FY 2021–22 contracts on behalf of the CDSS. CDSS childcare contracts will be issued on or about June 1, 2021. Detailed instructions on where to return an FY 2021–22 CDSS contract will also be included in the contract instructions.
