Campaign Integrity Contract

During my campaign I will abide by the following guidelines:

- I will not use obscenities in any form during my campaign.
- I will not deface or remove any other candidate's campaign materials.
- I will conduct myself with maturity and honesty throughout my campaign.
- I understand that I am responsible for the actions of my personal supporters and campaign helpers.
- I will accept the results of the election with maturity and respect.

I understand that if I do not abide by these guidelines that my candidacy may be subject to review.

Campaign Rules

General Criteria

- Appropriate language, free of putdowns, negative innuendos, and profanity, is to be used on all of your campaign materials.
- Posters and Banners must be taken down, at the LATEST, by YOU, by Monday, April 11th at 9:00 A.M. We are serious; take them down!
- Materials may be hung in the Gym Hallway, Cafeteria (Brick Walls Only!), and in Teacher Classrooms with their permission.
- Handouts including, but not limited to, candy, fliers (no larger than regular paper size 8.5 x 11), pamphlets, stickers, and buttons may be used with the understanding that any object that damages school property must be cleaned/removed at the expense of the candidate.

Poster Criteria:

- No more than 5 posters.
- Each poster must be no larger than 2' x 3' a combined total of this size may be used for 1 or 2 large posters of combined measurements.

Banner Criteria:

- No more than 1 banner.
- Banners must be no larger than 3' x 7'

Speeches

- Live speeches will be on ITV and cannot be longer than one minute.
 - * Failure to follow these guidelines may result in one's candidacy being reviewed.

Pace High School SGA Responsibilities Contract

- 1. I will be an exemplary student and citizen through my conduct and academic studies. This is a full time commitment for the entire term of office.
- 2. I understand that any suspension from school will cause for my immediate dismissal from my SGA position, unless an administrator overrules this.
- 3. I will enroll in and attend the SGA class for the entire year I am in office. If I am unable to be a member of the class, I will forfeit my position.
- 4. I will be in attendance for required SGA activities, and understand that I will receive demerits if I am unable to attend.
- 5. I will maintain a GPA of 2.5 or above, and I will have a guidance staff member verify my GPA on my Required Signatures Form.
- 6. I will need, at times, to be available before and after school, and on non-school days.
- 7. I will show and have respect for myself and others at all times. I will remember who I am and who I represent Pace High School and Student Government.
- 8. I understand and accept that PHS faculty members shall monitor the election results and those decisions will be final.
- 9. I have read and understand the PHS SGA Constitution.
- 10. I understand that in addition to outside of class time to complete SGA related tasks, that I am required to earn a minimum of 10 duty hours each nine weeks. These duty hours may be earned by supporting a PHS event (that I am not a part of), doing community service, helping a teacher, etc.
- 11. I further understand that during each nine week grading period, I will receive a duty hour grade. Each duty hour earned is worth 10 points out of a 100 point grade.
- 12. I understand that if elected/selected, I may receive demerits for various reasons (failure to turn in money in a timely manner, inappropriate behavior, failure to attend SGA functions, etc) and that earning 16 demerits will result in probation; 18 results in removal from the organization.
- 13. I further understand that during each nine week grading period, I will receive a demerit grade. Each demerit earned during that nine week grading period is a loss of 5 points of the 100 point demerit grade.
- 14. I understand that I may be asked to leave campus on SGA-related errands or field trips, and pledge to behave responsibly, reflecting the best of myself, SGA and school.
- 15. I understand that I will be working with equipment and supplies and will be held responsible for any damage and/or waste due to negligence.
- 16. I understand that if I am going to be absent, I need to call the advisor **prior to the beginning of class** and failure to do so may result in demerits.
- 17. I understand that I will be responsible for participating in various fundraising activities and that I am responsible for turning in all monies in a timely manner.
- 18. I understand that I will be expected to pay SGA dues in the amount of \$100 by the end of the first term of the school year. I understand that I will be given ample opportunities to raise these funds.

As the advisers, we understand that an SGA member has other obligations and responsibilities. Therefore, we will work individually with each member to make sure that he/she fully understands the commitment that is being made prior to assuming a responsibility. We want an open line of communication between members, officers, parents and us. We understand that it is my responsibility to provide an opportunity for all members to have hands on experiences that will teach time management skill, planning skills, organizational skill, conflict management, communication skill, personal development, leadership skills and much, much more.
