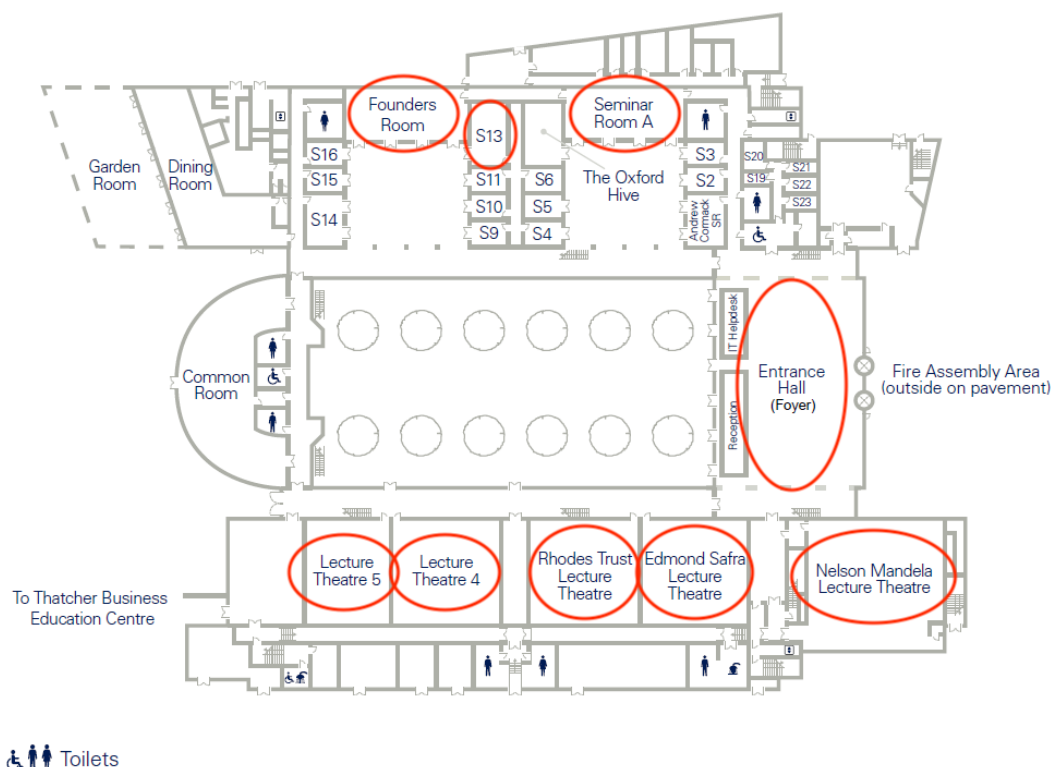

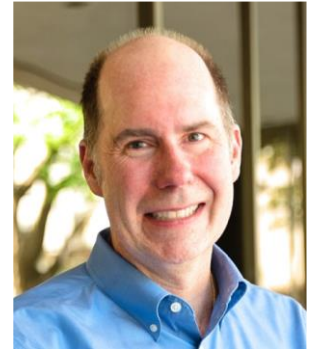

Welcome to Oxford, and to the University of Oxford's Saïd Business School, for the Industry Studies Association's first international conference. We are delighted that you have made ISA part of your conference community.

This year's theme is "Comparative Industry Studies and Public Policy in a Changing World." The premise of industry studies is simple: we cannot improve an industry without understanding the environment that makes it work: the distinctive demands, technologies, institutions, and human capabilities that shape its behavior. Renae keeps ISA running from day to day while steadily improving the online experience we provide to members and conference attendees. Finally, I want to thank John Gray. During his two years as president, ISA reached new heights, and he leaves the association in excellent shape as I take on this role.

Over the next few days, we will meet in some genuinely historic settings: sessions at Saïd, a welcome reception at Rhodes House, and a gala dinner in the dining hall of Balliol College, one of Oxford's oldest colleges. Opening Plenary: The Geopolitics of Industrial Policy

Thursday, September 3, 3.45pm – 4:45pm, Nelson Mandela Lecture Theatre (NMLT)

Lord Hague will be in conversation with Dr Monica Gorman on the shifting relationship between geopolitics, industrial policy, and the future of industry. Lord Hague will reflect on how strategic competition, technological change, national security, and economic resilience are reshaping the choices facing governments and firms. Dr Gorman will bring a complementary perspective from her recent White House work on manufacturing policy, supply chain resilience, and sectoral competitiveness, engaging Lord Hague on what these changes mean for industrial strategy on both sides of the Atlantic. The session will connect high-level statecraft with the practical realities of industry, offering an Oxford-based conversation on the policy, political, and geopolitical forces transforming contemporary industrial systems.



The Rt Hon Lord Hague of Richmond, Chancellor of University of Oxford

Lord William Hague of Richmond is Chancellor of the University of Oxford and one of the United Kingdom's most distinguished statesmen. A graduate of Magdalen College, Oxford, and former President of the Oxford Union, he served for 26 years in the House of Commons, including as Secretary of State for Wales, Leader of the Conservative Party, First Secretary of State, and Foreign Secretary. Throughout his career, he has been closely engaged with issues of international trade, economic competitiveness, energy security, geopolitics, and Britain's role in the global economy. Since leaving frontline politics, he has remained active in business and public policy and has co-authored reports with Sir Tony Blair advocating for a stronger national focus on science, technology, and innovation. An award-winning historian, author, and Fellow of the Royal Society of Literature, Lord Hague brings a unique perspective on the intersection of geopolitics, industrial policy, and national prosperity. He was elected Chancellor of the University of Oxford in 2024 and assumed office in February 2025.



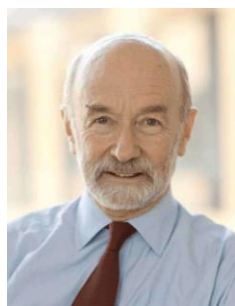
Moderator: Dr Monica Gorman

Dr Monica Gorman is Co-President (acting) of Crowell Global Advisors, and a former senior White House official whose work sits at the intersection of industrial policy, global trade, supply chain resilience, and corporate strategy. She served as Special Assistant to the President for Manufacturing and Industrial Policy from 2022 to 2025, where she helped establish the White House Council on Supply Chain Resilience and led the U.S. Supply Chain Disruptions Task Force. She previously served as Deputy Assistant Secretary of Commerce for Manufacturing, working on the competitiveness of strategically important sectors including semiconductors, pharmaceuticals, aerospace, automotive, nuclear, and solar energy. Before entering government, she held senior leadership roles at New Balance, American Eagle Outfitters, and Gap Inc., with responsibility for trade, compliance, sustainability, and global supply chains. Dr Gorman earned her M.Phil. and D.Phil. in Politics from the University of Oxford, where she was affiliated with St Edmund Hall and Nuffield College.

Plenary: Value Chains and Industrial Innovation Policy

Friday, September 4, 10.25am-11.25am, Nelson Mandela Lecture Theatre (NMLT)

Industrial innovation policy has returned as a major priority for national and regional governments around the world. While reservations about the wisdom and effectiveness of industrial policy continue in some quarters, it is now widely accepted that governments must have a considered position on their relationship with their industries. There are many challenges, however, to the development and delivery of effective industrial policies. This panel opens by exploring patterns of industrial innovation policy internationally, highlighting emerging trends and priorities. The UK Government's Chief Scientific Advisor will then introduce the UK's approach, drawing on the most recent national policies and early observations from their delivery. Finally, we draw together perspectives from different systems of industrial policy and explore ways in which these might usefully be integrated to provide more comprehensive and robust theoretical foundations for industrial innovation policy going forward.



Professor Emeritus Sir Mike Gregory CBE, FREng. Following an early career in industry Mike Gregory was the founder member of the team which established Cambridge University's Institute for Manufacturing (IfM) linking science, engineering, management and policy and integrating education, research and practice. He retired as Head of the Manufacturing and Management Division of the University of Cambridge's Department of Engineering and of the Institute for Manufacturing (IfM) and now chairs the Babbage Policy International Forum.



Professor Julia Sutcliffe was appointed Chief Scientific Adviser at the Department for Business, Innovation, Science and Trade in February 2023. She provides science and engineering advice and independent challenge to the department's ministers and senior officials, champions an evidence-based approach to decision-making, and builds internal scientific capability. She works with the network of departmental Chief Scientific Advisers and the Government Office for Science to resolve cross-cutting issues and maximise cross-government insights. Previously, she served as Chief Technologist at BAE Systems. Julia holds an Honorary Professorship in Computer Science at the University of Manchester, is a Chartered Engineer, and a Fellow of the Royal Academy of Engineering and the Royal Aeronautical Society. She has represented UK science and technology through a range of advisory council roles, including as the UK's industry representative on NATO Science and Technology Board and Programme Advisory Committee member for the UK Atomic Energy Authority. She is an advocate for science, technology, engineering, and mathematics (STEM) and diversity and inclusion within STEM professions.



Eoin O'Sullivan is the Babbage Fellow of Technology & Innovation Policy and the Director of the Centre for Science, Technology & Innovation Policy at the Institute for Manufacturing. He joined the Institute for Manufacturing as a Senior Policy Fellow in 2007. Since then Eoin has carried out research on the ways science and engineering R&D is translated in new technologies, industries and economic wealth. Eoin's policy-related activities have included studies for the UK Department of Business, Innovation & Skills; the Engineering & Physical Sciences Research Council; the UK Government Office of Science; Innovate UK; and Research England. Eoin has also worked with a range of international organisations, including the OECD, EU Commission, United Nations Industrial Development Organisation and US National Academies.

Drones: How Commercial, Security and Defence Demands Are Shaping an Industry

Thursday, September 3, 1pm-2pm, Rhodes Trust Lecture Theatre

Uncrewed Aerial Systems (UAS) - or Drones – are presented as a huge commercial opportunity by some, a security capability or liability by others and, with the Russia-Ukraine conflict front of mind, a profound defence challenge. Bringing together a manufacturer building dual-use systems, a police force flying beyond visual line of sight over national infrastructure, and the department shaping UK policy and industrial capability, the panel asks how an industry takes shape under these varied conditions. Where regulation decides what is feasible as much as technology does, where sovereignty and supply chains matter as much as capability, and where what works today is contested tomorrow.

	Moderator: Mike A. Lewis. Mike is Professor of Operations Management at the University of Bristol. His research spans supply chain resilience and the governance of emerging technologies, with current work on drones and governance of low-altitude airspace.
	Simon Bachelor is Head of the Drones Programme for British Transport Police, where he leads delivery of a Beyond Visual Line of Sight (BVLOS) capability to reduce disruption across the rail network. A senior leader with a thirty-year policing career, he previously ran the NPCC counter-drones portfolio embedded with the Home Office Counter Drones Unit, advising on the ATMUA Act 2021 and working with the CAA on regulatory reform. His work spans operational deployment, risk quantification and the industry liaison that turns emerging capability into safe, funded operations.
	Sofia Stayte is Head of Aviation Skills and Future of Flight at the UK Department for Transport, where she leads policy for the uncrewed and future-flight sector. An experienced government policy leader, she has worked closely with ministers and stakeholders across policy development, delivery and risk management, and is a CIPFA-trained public finance professional. Her work sits at the intersection of skills, regulation and industrial capability as the UK positions itself for uncrewed aviation at scale.
	Panelist from Tekever. Tekever is one of Europe's leading makers of UAS, headquartered in Lisbon with manufacturing and operations in Portugal, Britain and France. Founded in 2001, the company specialises in long-endurance intelligence, surveillance and reconnaissance (ISR) platforms and operates them as a service rather than simply selling hardware - a dual-use model spanning maritime surveillance for civil authorities and battlefield ISR. Its systems have been shaped by demanding operational environments, including maritime patrol and the war in Ukraine.

Public Policy and the Digital Stack

Thursday, September 3, 1pm – 2pm, Lecture Theatre 4

Online platforms have become essential infrastructures of modern capitalisms. In recent years, a few hyperscalers have shifted from consumer- to enterprise-oriented services, and from asset-light service providers to asset-heavy orchestrators of a multilayered digital stack. As digital technologies transform legacy manufacturing industries, this evolution is reshaping entire production systems. Unsurprisingly, the digital stack has become a central feature of international political and economic conflict. It has also risen to the top of national agendas for economic security, sovereignty, resilience and competitiveness. But how did we get there? And what does it portend? Are the two countries that own their own digital stacks set to dominate the global political economy? Can mid-sized economies with real technological capabilities become countervailing forces? Can these middle-powers leverage existing specializations in complex manufacturing industries to build innovation in critical areas of technology to protect their interests and remain relevant in the global arena? And can they do so without compromising existing commitments to fair employment and environmental sustainability?



Moderator: Angela Garcia Calvo is Assistant Professor at the University of Reading. Her research studies how governments, and firms work together to transform capitalisms and shape the direction of technological change. Specific topics include industrial-innovation policy, the platform economy and state-firm relations. Garcia Calvo's ongoing project "Empowering Europe" asks how can Europe generate new technological capabilities to generate prosperity, guarantee their security and maintain a meaningful position in the global sphere.



Diane Coyle is the Bennett Professor of Public Policy at the University of Cambridge and a member of the UK Government's Industrial Strategy Council. Her research focuses on productivity, the digital economy and AI policy, and economic measurement. She has been writing about the effects of digital technologies since her first book, *The Weightless World*, in 1997. The underlying motivation for all her work is the question: what does it mean for the economy to improve, and who benefits?



Annabelle Gawer is a Chaired Professor in Digital Economy and Director, Centre of Digital Economy (CoDe) at the University of Surrey. A world-class academic pioneer in platform strategy, Professor Annabelle Gawer's seminal research offers insights into the strategic management of platforms and the governance of their innovation ecosystems by exploring systematically the interaction between economic forces, organizational dynamics, and technological design.

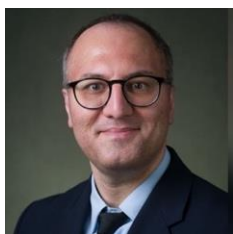


Helena Malikova is a European Union civil servant with the Directorate General for Competition (DG COMP) at the European Commission. She is currently leading the directorate's work on intelligence gathering and investigations and is researching the valuation of strategic M&A facilitated by foreign governments. She has published on the geopolitics of artificial intelligence and conflicts of interest among antitrust economists, academics and economic consultancies advising on regulation.

Space: Can the Final Frontier Become a Market?

Friday 11.30AM – 12.30AM, Rhodes Trust Lecture Theatre

Space has become one of the most strategically significant industries of this century. Once the preserve of government agencies pursuing scientific, military and exploratory missions, it now underpins communications, Earth observation, climate monitoring, and national security. Yet a central question remains open: can space become a genuine market, or will its structure, demand and economics remain largely shaped by the state? What makes space unusual is that markets here often have to be built before demand is visible. Governments, investors, and firms must make long-term commitments under extreme uncertainty, and the commercial landscape is shaped as much by public procurement, industrial policy, and venture capital as by ordinary consumer demand. Bringing together speakers from venture capital, the space and defence industry, the UK Space Agency, and academia, this panel asks how space markets are created, financed, and governed. In doing so, we address a broader question of how markets are constructed when demand, technology, and industry boundaries are all still being formed?



Moderator: Mehdi Montakhabi is Associate Scholar at Saïd Business School, University of Oxford. His research examines how nascent ecosystems emerge and scale in uncertain, highly regulated, and state-shaped markets, with a particular focus on commercialization in the space economy. He is also the founding organiser of the Academy of Management PDW on the space economy.



Dr Paul Bate is the former Chief Executive Officer of the UK Space Agency, where he led the UK's civil space agency in advancing space science, commercial growth, and the use of space for economic, environmental, and societal benefit. In his role he oversaw national efforts to support R&D, space infrastructure, and the UK's role in international space activity.



Rob Desborough is General Partner at Seraphim Space and Chair and co-founder of the Seraphim Space Accelerator. He has played a central role in building Seraphim's early-stage Space-Tech investment platform and supporting high-growth ventures across the space sector. His work focuses on identifying, backing, and scaling companies developing technologies and applications in areas such as communications, Earth observation, climate, defence, infrastructure, and space-enabled data.



Nigel Chandler is Head of Sales / Global Business UK at Airbus Defence and Space, where he leads customer engagement across UK defence and space markets. He works to connect advanced space capabilities with government, institutional, and commercial customers. His background spans customer strategy, large-scale programme development, and the translation of complex technological systems into market and mission needs.

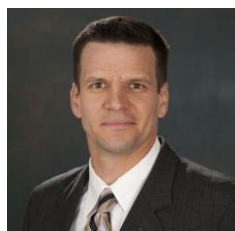


Raja Roy is an Associate Professor at the New Jersey Institute of Technology and holds a Ph.D. in Strategic Management from the University of Pittsburgh. His research focuses on technological innovation in high-tech industries, including industrial robotics, image sensors, and spacecraft. His publications have explored NASA's knowledge development for the Space Shuttle and digital image sensors for the Hubble Space Telescope. His ongoing research examines NASA's Ingenuity Mars Helicopter, the Voyager spacecraft, and ISRO's Chandrayaan-1. Dr. Roy has published 20 peer-reviewed papers and presented his research to NASA and the U.S. National Academies of Sciences, Engineering, and Medicine.

Drug Shortages: Drivers, Consequences, and Solutions

Friday 11.30AM – 12.30PM, Lecture Theatre 4

Drug shortages have hit record highs worldwide. In addition to causes common to all global industries (e.g., national disasters and geopolitical disruptions), in the pharmaceutical industry there is also a mix of manufacturing fragility, market economics, regulatory friction, and supply chain opacity. The consequences of drug shortages ripple from clinical care to public trust. This panel brings together research, policy, and industry perspectives to unpack the drivers of shortages, public policy responses, and private sector solutions. Discussion will draw on firsthand experience managing drug supply, covering the underlying economics, such as rewarding manufacturers for staying in markets with razor-thin margins, a tendency for single sources of supply, and environmental regulation continuing to push production toward Asia. Expect insights from work with data and decision-makers across several countries, and a live demo of predictive tools that flag shortage risk before it hits the shelf.



Moderator: John Gray is a Dean's Distinguished Professor, and the Chair of Operations and Business Analytics Department at Fisher College of Business, The Ohio State University. He is currently the PI on a subaward grant from the U.S. Department of Defense, charged with examining global pharmaceutical supply chains. Prior to pursuing his PhD, John worked at Procter & Gamble. He was co-PI of a contract with the FDA, part of a major FDA subaward, and co-PI on an NSF grant. John is also the past president of the Industry Studies Association (ISA).



Dr. Markus Felgenhauer is Co-Founder and Chief Executive Officer of QYOBO, a live intelligence platform providing data-driven insights into global pharmaceutical supply chains. QYOBO integrates hundreds of data sources to deliver transparency and live intelligence on manufacturing networks, compliance risks, pricing dynamics, and supply chain vulnerabilities across the pharmaceutical industry. Before founding QYOBO in 2019, Markus worked at McKinsey & Company, where he focused on the pharmaceutical sector. At QYOBO, Markus leads strategy, product innovation, and commercial development. His work focuses on bringing greater transparency and intelligence to pharmaceutical supply chains.



Damien Holly is VP, Head of Global Supply Chain at SERB Pharmaceuticals. Damien has extensive experience in supply chain and operations management, having served as the Chief Operations & Quality Officer at Provepharm Life Solutions and worked at Novartis as the Head of Supply Chain for the Sandoz Division. He also held the position of Director of Global Supply Chain at Hexcel Corporation, Director of European Supply Chain and Technical Services at Mundipharma International, and had various roles at Pfizer, including Director of Global Supply Chain Processes and Director of EMEA Supply Chain.



Mujaheed Shaikh is Professor of Health Economics and Policy at the Hertie School, Berlin. His research combines applied econometrics with public policy to address pressing challenges in global and European health systems, including medicine shortages, ageing populations, and access to healthcare. He has published his work in leading international journals and has informed policy discussions among governments, international organizations, and healthcare stakeholders. He has led and collaborated on several international research projects funded by organizations including the German Research Foundation (DFG) and the European Union.

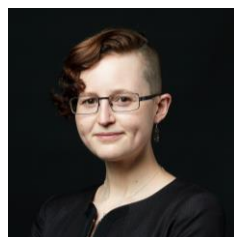
When the Chips are Down: Europe's Stake in the Global Chip War

Friday 3.10PM – 4.10PM, Rhodes Trust Lecture Theatre

The global semiconductor industry is in the midst of a historic transition, driven by geo-strategic rivalry, growing demands for supply chain resiliency, and China's rapidly expanding role in mature-node manufacturing. While public attention gravitates toward the most advanced chips, the sharpest competitive pressures are emerging in the power and foundational semiconductors that underpin Europe's automotive, industrial, and energy sectors. As products across nearly every industry come to depend on an increasingly complex and growing array of chips, semiconductor competition is no longer a story confined to the chip industry itself. This panel draws together corporate strategy, industrial policy, and technology commercialization to examine what is actually at stake and assesses where the industry is heading, what it means for Europe's downstream industries, and which policy responses can meet the moment.



Moderator: Travis Mosier. Travis is Executive Advisor at mySilicon Compass, where he advises semiconductor firms and governments on competitiveness, investment, and supply chain strategy, and an Adjunct Senior Fellow at the Center for a New American Security. He began his career in China in 2001 as a Visa Officer with the Australian Consulate-General and later led a 12-person team at the New Zealand Consulate-General. During twelve years at the U.S. Department of Commerce, including six years negotiating U.S.-China trade and market access, he co-authored the 2021 White House Semiconductor Supply Chain Report, helped design the CHIPS for America implementation plan, and earned the Department's Gold Medal for securing TSMC's \$12 billion U.S. investment. He holds a Master of International Affairs from Columbia University.



Dr Katie Hore is the Innovation Director at REWIRE, the UK's Innovation and Knowledge Centre for next-generation power semiconductors. REWIRE brings together the Universities of Bristol, Cambridge and Warwick with industry partners to accelerate the development and commercialisation of (ultra-)wide bandgap semiconductor devices. The Centre is driving UK progress toward net zero, strengthening sovereign capability, and building a resilient, globally competitive semiconductor supply chain. Katie has more than a decade of experience in the semiconductor industry, spanning power electronics, optoelectronics, and quantum technologies. She holds a DPhil in Chemistry from the University of Oxford.



Sebastian Weiske is Senior Manager Strategy Development at Infineon Technologies, a global leader in semiconductor solutions for automotive, power management and IoT. He leads macroeconomic and market intelligence activities within Corporate Strategy, advising senior management on global economic trends, geopolitical developments, and market shifts that shape the semiconductor industry. Prior to joining Infineon five years ago, Sebastian worked as a macroeconomist and policy advisor at the German Council of Economic Experts. He holds a PhD in Economics from Goethe University Frankfurt.

Infrastructure—From Concrete to Cloud: A Laggard Leviathan or a Leading Light?

Friday 3.10PM – 4.10PM, Lecture Theatre 4

Delivering large-scale infrastructure is fundamental towards realizing our future societal ambitions and meeting our global grand challenges. On the one hand, age-old challenges still exist - uneven skilled labour availability, operational complexity, and time-cost-quality pressures amidst ever increasing geopolitical turmoil and economic turbulence. On the other hand, we see remarkable advancements in machine learning, robotics & physical AI, nuclear fission & fusion, renewables, to name only a few, that are allowing us to reimagine the possible. In this panel, we will explore what this duality spells for the future of infrastructure. Will we continue to genuflect to age-old problems that continue to seemingly spring anew or will these novel breakthroughs allow us to inflect to a new reality? The answers do not just have implications for those leading, studying, or enacting large-scale projects and policy around infrastructure but also for those seeking to use these assets as springboards for new imaginative futures.



Moderator: Daniel Erian Armanios is the BT Professor and Chair of Major Programme Management at Saïd Business School and a Professorial Fellow of St Anne's College. He also holds a Courtesy Appointment with the Department of Engineering Science. Daniel's research integrates civil engineering and organisational theory to better understand how organisations coordinate to build, manage, and maintain infrastructure amidst complexity. His work is published in leading outlets across the engineering and social sciences, and he has consulted and served on various panels and advisory boards for organizations such as the US National Academy of Sciences, Engineering, and Medicine (NASEM), UNDP, US Department of Transportation (DOT), amongst others.



Alison Baptiste CBE CEng FICE is a Director in the National Infrastructure and Service Transformation Authority in the Treasury which is the government centre of expertise for project delivery. She drives standards, improvements and pace in government's biggest and riskiest projects bringing. Her portfolio covers infrastructure and service delivery in Defence, Digital, Health, Education, Welfare, Home Office, Justice and Tax. She also leads the cross-government forum on Transformation programmes. Prior to this Alison led operational delivery in the Environment Agency and received a CBE for her leadership responding to nationwide flooding. Alison also holds non-executive roles in the engineering profession and leisure industry and is passionate about driving positive outcomes for people.



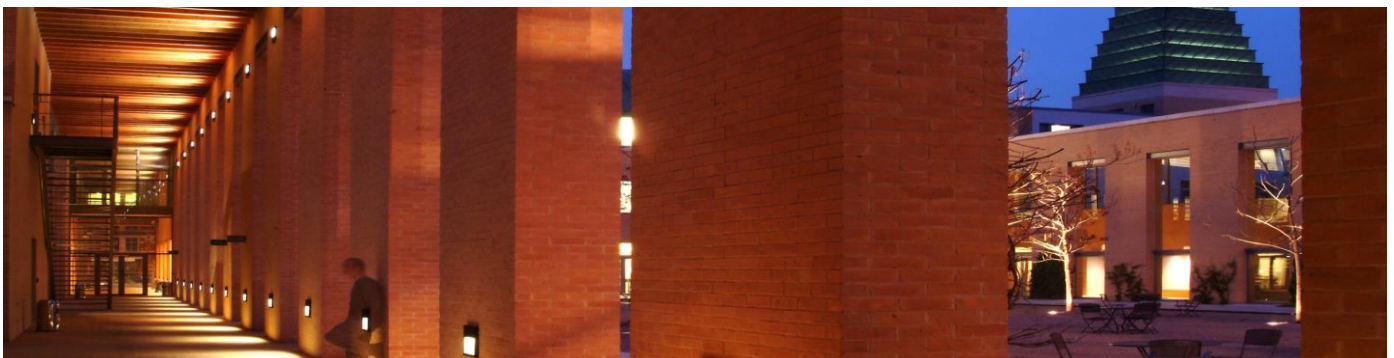

She joined Agilia Infrastructure Partners as Executive Chair in April 2026. She served as Joint Managing Director of Sizewell C, the new nuclear power station under construction in Suffolk. Julia Pyke joined the project in 2017 as Development Director and later became Joint Managing Director. She stepped down from the role in December 2025. Prior to that, she spent over two decades at Herbert Smith Freehills, where she became a senior partner and Head of Power and Renewables for Europe. She currently serves as a Clean Power Commissioner for the UK Government and a non-executive director of Studsvik. Julia is a Fellow of the Energy Institute and the Nuclear Institute. She was awarded a CBE in the 2026 King's Birthday Honours for her services to the energy industry.



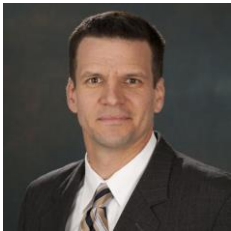

What is Industry Studies Research?

Industry studies draws on perspectives from strategy, organization theory, operations, innovation, and public policy, yet its distinctive contribution remains a subject of ongoing discussion. At its core, industry studies seeks to understand how industry-specific characteristics shape organizational, firm, and industry outcomes through attention to the technologies, institutions, competitive dynamics, and historical trajectories that define particular sectors. This panel brings together leading scholars to explore what defines industry studies research, the questions it is uniquely positioned to answer, and its relevance for addressing contemporary challenges. Panellists will discuss industries as a critical level of analysis, the balance between industry-specific insight and broader theory development, and the opportunities and challenges of conducting and publishing industry-focused research. Reflecting on the field's evolution, current boundaries, and future directions, the discussion will offer perspectives on how industry studies can contribute to understanding industries as complex systems of competition, collaboration, innovation, and change, while providing practical guidance for scholars interested in advancing this distinctive area of research.



Moderator: John Gray is a Dean's Distinguished Professor, and the Chair of Operations and Business Analytics Department at Fisher College of Business, The Ohio State University. He is currently the PI on a subaward grant from the U.S. Department of Defense, charged with examining global pharmaceutical supply chains. Prior to pursuing his PhD, John worked for eight years in operations management at Procter & Gamble. He was co-PI of a contract with the FDA, part of a major FDA subaward, and co-PI on an NSF grant. John is also the past president of the Industry Studies Association (ISA).



Saurabh Bansal is a professor of supply chain management and faculty of operations research at Pennsylvania State University. His research examines decision-making under risk and uncertainty, and he works with firms to investigate such problems for various industry domains. He has published in *Operations Research*, *Management Science*, *Production and Operations Management*, among others. He's an associate editor at *Operations Research*, *Manufacturing and Service Operations Management*, *Production and Operations Management*, and *INFORMS Journal on Applied Analytics*. More recently, he has worked in the office of the CFO of Penn State to execute a shared services business model. Saurabh serves as the Department Editor for the Industry Studies and Public Policy section at Production and Operations Management.



Laura Dupin is an Assistant Professor of Entrepreneurship and Innovation at the University of Amsterdam Business School. Her research examines local, industry-specific firm competitive dynamics, combining archival, experimental, and qualitative methods. Her work has traversed the French bread market, the Dutch cannabis "coffeeshop" industry, and Chicago movie theaters during the 1920s sound-technology transition, and has appeared in *Administrative Science Quarterly*, *Organization Studies*, and *Harvard Business Review*. She is an inducted member of Amsterdam Young Academy, a 2024 fellow at the Netherlands Institute of Advanced Study, and recent recipient of a NWO Veni young talent grant.



Juliane Reinecke is Professor of Management Studies, and Faculty Director for Sustainability at Saïd Business School, University of Oxford. Juliane uses qualitative methods to study the emergence of or change towards sustainable industries (i.e. food, garments, minerals, energy), and the role of collective action, social movements, multi-stakeholder collaboration and transnational governance therein. Her work has been published in *Academy of Management Journal*, *Academy of Management Review*, *Administrative Science Quarterly*, *Journal of Management Studies*, and *Organization Science*, among others. Juliane received her MPhil and Ph.D. from the University of Cambridge.

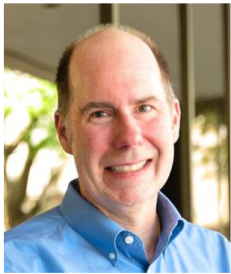
Resilience and Reconfiguration of Global Supply Chains

Saturday 5 Sept, 10.30am-11.30am, Lecture Theatre 4

As geopolitical tensions, technological disruption, and systemic vulnerabilities reshape global supply chains, new approaches to resilience are emerging. This panel examines four critical themes: (1) managing cascade risks in increasingly interconnected supply networks; (2) the growing use of supply chains as instruments of statecraft through export controls, technology restrictions, and resource access; (3) industrial resilience and supply chain reconfiguration driven by breakthrough technologies and new organisational models; and (4) the opportunities and risks created by agentic AI systems, including new approaches to visibility, coordination, and risk management. Together, the discussion explores how firms, industries, and governments can adapt to an increasingly uncertain global environment.



Jagjit Singh Srail is Professor of Manufacturing and Head of the Centre for International Manufacturing at the University of Cambridge's Institute for Manufacturing. His research focuses on the design and operation of global supply chains, particularly the impact of new production and digital technologies on supply chain configuration and resilience. He has published over 100 journal articles, secured major research funding from UKRI, Europe, and industry, and serves on international initiatives including the World Economic Forum's Advanced Manufacturing Council, where he was Co-Chair from 2019–2025. Prior to academia, he held senior supply chain and technical leadership roles at Unilever. He holds degrees from Aston University and the University of Cambridge and is a Chartered Engineer and Fellow of the Institution of Chemical Engineers.



Edward Anderson is the Betty and Glenn Mortimer Centennial Professor of Business at the University of Texas at Austin's McCombs School of Business. His research focuses on supply chain innovation, information systems, industrial policy, AI adoption, B2B platforms, and critical minerals. He has studied industries including automotive, electronics, software, and healthcare. Anderson has appeared in major media outlets including the BBC, Associated Press, Yahoo, Fortune, and Fox News, and has testified before the Texas Senate on supply chain disruption. A Fellow of the Production and Operations Management Society, he is also a research affiliate at MIT Sloan. He has authored more than 40 research articles and co-written *The Innovation Butterfly* and *Operations Management for Dummies*. Before academia, he worked as a product development engineer at Ford Motor Company and holds degrees from Stanford University and MIT.



Nitin Joglekar is the John F. Connelly Endowed Chair in Management at the Villanova School of Business and convener of its Human-Centric and Agentic AI Lab. His research examines AI context estimation, agentic data platforms, AI guardrails, workflow reconfiguration, and industrial policy, with applications in critical minerals, financial services, and retail supply chains. He has more than 20 years of experience in the energy and IT sectors and has founded, advised, and consulted with venture-backed startups and established firms on AI, business strategy, and data platforms. Professor Joglekar serves as Department Editor for Digital Platforms, Innovation and Transformation at *Production and Operations Management*. He holds a B.Tech. (Hons) from IIT and master's and doctoral degrees from MIT.

Research streams

1. Energy, Sustainable Innovation, and Mobility (EN)

This stream invites papers and panels on the changing market and public policy landscape where the energy industry (including oil and gas, electricity, pipelines) intersects with environmental concerns.

2. General Industry Studies (GO)

Any research on issues or industries not covered in other research streams described above may be submitted to this general stream. Papers or organized panels comparing phenomena, trends, issues, or economic activities across occupations, industries, or geographic regions.

3. Health Care Systems, Biotechnology, and Pharmaceuticals (HC)

This stream invites papers and panels that examine the myriad of issues surrounding effective management of health care entities and systems (e.g., hospitals, medical groups, public health agencies, insurance companies, pharmaceutical firms, technology companies, etc.).

4. Innovation, Entrepreneurship, and AI-Driven Transformation (IE)

5. Labor Markets, Organizations, and the Future of Work (LM)

This stream welcomes papers and panels that examine the impacts of firm, industry, and market characteristics on labor markets, industrial relations, and/or human resource practices as well as public policy outcomes.

6. Operations, Supply Chain, and AI-Enhanced Industry 4.0 (OP)

This stream welcomes papers and panels that are concerned with the oversight, design, and control of the business processes responsible for the production of goods and services as well as those focused on coordination of (multiple) firms responsible for these business processes within a supply network.

7. Public Policy, and Global Competitiveness (PP)

Public policy – whether national, regional, local or global – often shapes opportunities for industries, including competitive options within industries and globalization of industries. In turn, wrestling with these opportunities, competitiveness and globalization have had a profound impact on the nature of industrial activity and policy.

8. Cross-Track (X-Track)

This stream includes papers that span multiple conference streams, and address the same industry sector or broad phenomena, or contexts.

Historic Pubs

- **Turf Tavern**, 7 Bath Place, Oxford OX1 3SU – Oxford's most famous hidden pub, tucked beside the medieval city wall and a long-standing haunt of students, academics and visitors
- **The Bear Inn**, 6 Alfred Street, Oxford OX1 4EH – One of Oxford's oldest pubs, dating from 1242, renowned for its historic atmosphere and collection of college ties.
- **The King's Arms**, 40 Holywell Street, Oxford OX1 3SP – A classic Oxford academic pub opposite the University's historic centre, popular with faculty and students alike.
- **The Oxford Retreat**, 1 Hythe Bridge Street, Oxford OX1 2EW – A popular Oxford pub and restaurant, and the closest pub to Saïd Business School

Going for a run?

- **Oxford Canal & Port Meadow (flexible distance)** – From Park End Street or Hythe Bridge Street, join the Oxford canal towpath and follow it north through Jericho to Port Meadow.
- **Thames Path & Iffley (flexible distance)** – Start at Folly Bridge and follow the Thames riverside path along the Christ Church Meadow side of the river toward Iffley Lock.
