successful businesses. We're bringing resources to traditionally underserved populations as a step forward on the journey towards a more equitable economy. The curriculum for this program was selected because of its proven impact on the lives of individuals and communities with the potential to transform the economic landscape of the Lowcountry. Over the course of 2020 we trained 48 emerging entrepreneurs through our inaugural Community Business Academy, which is a 12-week entrepreneurship course and the first phase of the three phase Good Enterprises program which also included Business Accelerator Services and Connecting to Capital. Of those who graduated 70% qualify as low-to-moderate income 86% were people of color and 70% were women. The trajectory for the program will be to continue to offer the program virtually if necessary, in person when possible, and to offer the course in both English and Spanish in 2021.

Local Works, our coworking space provides flexible, affordable space for small business owners, entrepreneurs and remote workers. Since inception 131 new jobs have been created, \$430,000 paid to locally-headquartered companies, 201 new business connections and 41% women-owned businesses have been served.

As the COVID-19 pandemic started, Local Works shut down operations and only allowed full-time lessees into the office and also reduced rents in try to

support our customers. In April 2020, Local Works team decided that this would be the most strategic time to expand. Local Works closed its doors mid-June 2020 to prepare for the moveout from its current space the last week of June 2020. The new Local Works space (and new corporate office) soft opened on December 15, 2020 and opened fully and officially January 4, 2021.

#### Good Farming

Furthermore, we continue to support the expansion of a vibrant local food system through our Good Farming Initiative and have formalizing a partnership that will make our work in sustainable agriculture and food systems even more accessible moving forward. Apprenticeship opportunities and community education continue to be an integral part of this work.

#### Good Business

Good Business remains our core work, to advocate on behalf of the local businesses that are the heart and soul of our communities, those that provide the majority of jobs and make our economy one that is more equitable and resilient. Through our annual Good Business Summit we bring thought leaders nationally and locally together to share big ideas as well as challenges and promote the idea of businesses not only doing well but also good, which benefits our society as a whole.
