We're bringing resources to traditionally underserved populations as a step forward on the journey towards a more equitable economy. The curriculum for this program was selected because of its proven impact on the lives of individuals and communities with the potential to transform the economic landscape of the Lowcountry. This past fall we graduated 23 students from our inaugural Community Business Academy, which is a 12-week entrepreneurship course and the first phase of the three phase Good Enterprises program which also included Business Accelerator Services and Connecting to Capital. Of those who graduated 70% qualify as low-to-moderate income 87% were people of color and 61% were women. The trajectory for the program will be to triple the number of classes in 2020 and offer the course in Spanish by 2021.
