

# 2025-2026 Leadership Institute for Executive Directors Program Overview

MANP's *Leadership Institute* offers current nonprofit executive directors at any point in their careers dedicated time and space to reflect, set goals, and develop plans to not only strengthen their leadership, but to catalyze cultures of learning and shared leadership within their organizations.

The curriculum is rooted in leadership development best practices and a commitment to practical application. Participants will:

- develop a personal leadership vision;
- sharpen their ability to recognize and build on the strengths of themselves and others;
- practice coaching skills for developing the next generation of leaders;
- > strengthen team leadership skills; and
- plan a learning strategy for themselves and their organizations.

The ultimate goal of *Leadership Institute* is to increase the ability of each participant to shape and guide strong, adaptable organizations that are respected partners in creating, sustaining and improving Maine's quality of life.

#### Format + Schedule

This nine-month hybrid program **begins and ends with 2-day, in-person retreats**. In the months between, there are **virtual meetings**, a **mid-year in-person gathering** with program alumni, and **one-on-one coaching sessions** for each participant.

One-on-one coaching is scheduled to meet participant calendars and preferences during the time periods noted below and take place virtually.

#### **Time Commitment + Pre-Work**

- > Participating in the Leadership Institute requires a serious investment of time from all participants. Participants are expected to attend all sessions and complete all pre-work to ensure a meaningful learning experience for everyone in the group. Full participation in the September opening retreat is mandatory.
- > Nonprofit Leadership 360 Feedback Assessment: The purpose of the 360-feedback process is to help participants understand their relative leadership strengths and development opportunities.
  - Participants are provided with an individualized link through which the assessment will be completed by the participant and, ideally, a minimum of 6 respondents including board members, staff, volunteers, and other colleagues. This assessment has a total of 60 questions and should take no longer than 15-20 minutes to complete.
- > CliftonStrengths Assessment: This online assessment measures an individual's natural patterns of thinking, feeling, and behaving. Participants will discover which talents they rely on to build relationships, think strategically, execute plans, and influence others to accomplish goals. Participants are provided with a web link and individual code to complete this assessment.

## **Cost of Program**

**Leadership Institute fee is \$3,000 for MANP members and \$3,500 for nonmembers.** Applicants whose organizations are not members are encouraged to join (check your membership status <a href="here">here</a>).

The program fee includes all materials, assessments and approximately 60 hours of in-person retreats, virtual meetings and private coaching. *Please note:* travel expenses to and from in-person retreats and any lodging costs before, during, or after sessions are not covered by tuition.

MANP works to ensure cost is not a barrier for anyone accepted into the program and offers financial assistance and payment plans, which can be requested as part of the application process.

### **Important Program Deadlines**

- ▶ May 9: Applications Due
- ▶ Week of June 2: All applicants notified whether they have been accepted to the program
- ▶ **By June 23:** Participants confirm participation
- **By July 18**: For those accepted, a nonrefundable deposit of \$250 is due
- ▶ **By August 1:** Pre-work sent to participants, including instructions on how to complete assessments
- ▶ August 22: Deadline to complete the Nonprofit Leadership 360 Assessment
- ► **September 11**: Tuition due in full (\*If tuition deadline presents a barrier, a payment plan can be arranged at time of acceptance)
- September 25 + 26: Opening retreat at Schoodic Institute in Winter Harbor
