- A. Attendees Joel Martinez, Matt Wheldon, Sally Duffy, Lashone Bedford, Greg Alimmenti, Jonelle Moore, and Rebecca Chesnut. The meeting began at 10:06 a.m.

- D. Feedback from October Meeting with Section Staff and Board Liaison J.   - 1. Regional Seminar Planning –This group will begin work on spring regionals soon.

  - 3. <u>U.P.</u> G. Alimmenti stated the UP Conference is being scheduled. It will take place on 4/1 and 4/25/25. The meeting site is set and they have 19 presentersin the works.
