MI-AWWA Training Subscription pilot program



MI-AWWA is piloting a training subscription program for 2021. This is an opportunity to take advantage of the virtual learning environment for professional development and growth.

Once subscribed, you will be set up in the Learning Management System (LMS) and invited to explore topics and take classes as they are added to the LMS Library. LMS classes range from 5 minutes to several hours and cover a wide range of topics. Many are self-directed and on-demand which allow you the flexibility to complete them when and where you want and at the pace that works best for you. You will also be given a confidential subscription code to register for live virtual trainings or the virtual portion of hybrid trainings offered throughout the year at no additional cost. You will earn CECs, if available, as you complete each course. Note - not all trainings have been approved for CECs.

During the pilot program, we will offer two subscription types – Individual and Organizational.

Individual Subscription

An individual training subscription offers complete access to all trainings available in the Section's Learning Management System as well as virtual and hybrid trainings for the year.

Member rate \$500; Nonmember rate \$750

Organizational Subscription

A member organization (utility, service provider, etc) may enroll in the training subscription and may use it for three named employees to access all trainings available in the Section's Learning Management System as well as virtual and hybrid trainings for the year.

Organizational member rate \$1,000. This subscription is not available to other MI- AWWA member types or non-members.

Who Would the Training Subscription Benefit?

The Training Subscription would be good for anyone interested in professional growth and development in addition to earning continuing education credits or professional development hours.

What Does the Training Subscription Include*?

Subscribers get access to all self-directed classes available in the Learning Management System as well as complimentary registration to any virtual training offered during the year, with the exception of Michigan Water Academy classes, conferences and symposia.

When Does the Subscription Start and End?

The 2021 subscription is by calendar year and so begins upon purchase and expires December 31, 2021.

Where Can a Subscriber Take Classes?

The beauty of the subscription is you can participate from any device, although Windows and Chrome are the best environments. With on-demand classes, you can take those at any time. The scheduled online classes can be taken from anywhere with a reliable internet connection and internet-enabled device.

Why Is the Section Offering a Training Subscription?

The Section is exploring how to bring more training and more value to water professionals. At the same time, we need the same water professionals to provide Quality Assurance and Quality Control for our Learning Management System. Subscribers will be expected to periodically complete evaluations and feedback forms to help us understand the subscriber's experience and how to make improvements to maximize value.

Subscription Agreement

By paying for the subscription through MI-AWWA's website, you (the "Subscriber") hereby subscribe to access to the Learning Management System ("LMS"), and to any virtual trainings offered during the year 2021 by MI-AWWA with the exception of Joint Expo & Operators Day, MI-ACE, classes identified as the Michigan Water Academy, and any other conferences or in-person events. Your subscription is active within 24 hours of payment in full received.

The Subscriber hereby acknowledges and agrees that access to training including login credentials, promotional codes, or other tools that enable access to virtual training are for the sole individual use of the subscriber and that no access or registration shall be sold, issued, or transferred to any other individual. An individual found to be taking a class through unauthorized access to subscriber credentials will be billed the full late registration rate for the class. Subscribers found to be sharing their credentials may be withdrawn from the subscription program and forfeit their subscription fee.

Subscriber will be responsible for logging into the LMS at least once during the year. Further, Subscriber understands that to gain complimentary registrations, the Subscriber must log in to the MI-AWWA website when registering and must use the subscriber (or promotional) code issued with the LMS credentials in order to confirm complimentary registration. It is the sole responsibility of the Subscriber to register or not for any desired class covered under the subscription.

By accepting payment and issuing login credentials to the LMS, MI-AWWA acknowledges and agrees to provide a minimum of 24 hours of virtual training during the year.

Subscriber understands that continuing education credits may not be available for all virtual trainings. Subscriber acknowledges and agrees that MI-AWWA nor any other person has represented, guaranteed or warranted that any particular results will be achieved by participating. There are no assurances that any specific outcome will be achieved by participating in the available trainings.

Subscriber understands that once login credentials are issued, no refund will be available.
