
- + UK Patent attorneys are not lawyers

23 June 2016 – Referendum - UK votes to leave EU


31 January 2020 – UK leaves European Union

Brexit - Patents

The relevant Patent Offices are not EU institutions

- European Patent Office
- WIPO
- UK Intellectual Property Office

- No significant effect on EPC
- EP patent applications can still be filed at EPO and cover same European territories including the UK

Brexit – Community Trademarks/Designs

Managed by European Union Intellectual Property Office (EUIPO)

Pan-European IP Rights

- Community Trademarks
- Community Registered Design Right (like Design patents in US)

Holders of existing Community IP rights were granted comparable UK IP rights

Representation - Post Brexit – UK attorneys lost representation at EUIPO

- A+I - Have opened office in Delft, NL
- Have EU attorneys based in NL for EU TM and Designs work


UPC - Unitary Patent and Unified Patent Court

- + Two prongs
 - A single court for EU
 - A unitary patent right across EU

An EU initiative – for several decades!

- + Expected late 2022/2023-ish
- + Only a subset (27/38) of EPC contracting states are in the EU
- + UK not able to take part since Brexit
- + Separate UK patent required


