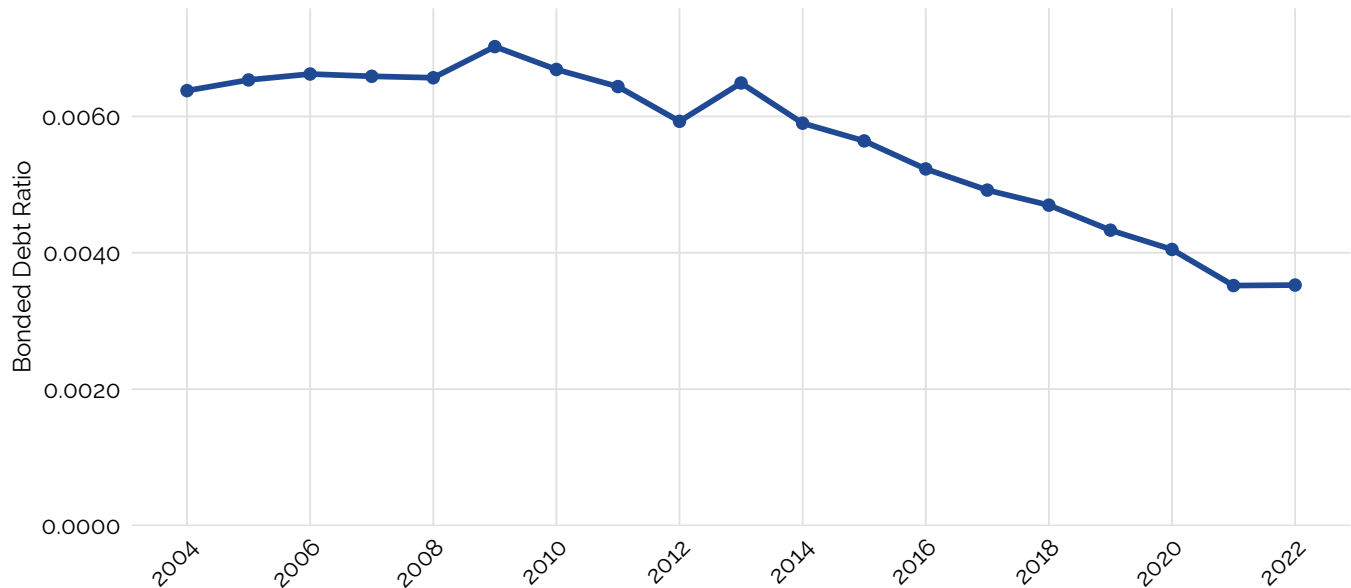

Figure A.57: 20-Year Bonded Debt to 20-Year Personal Income — New Hampshire

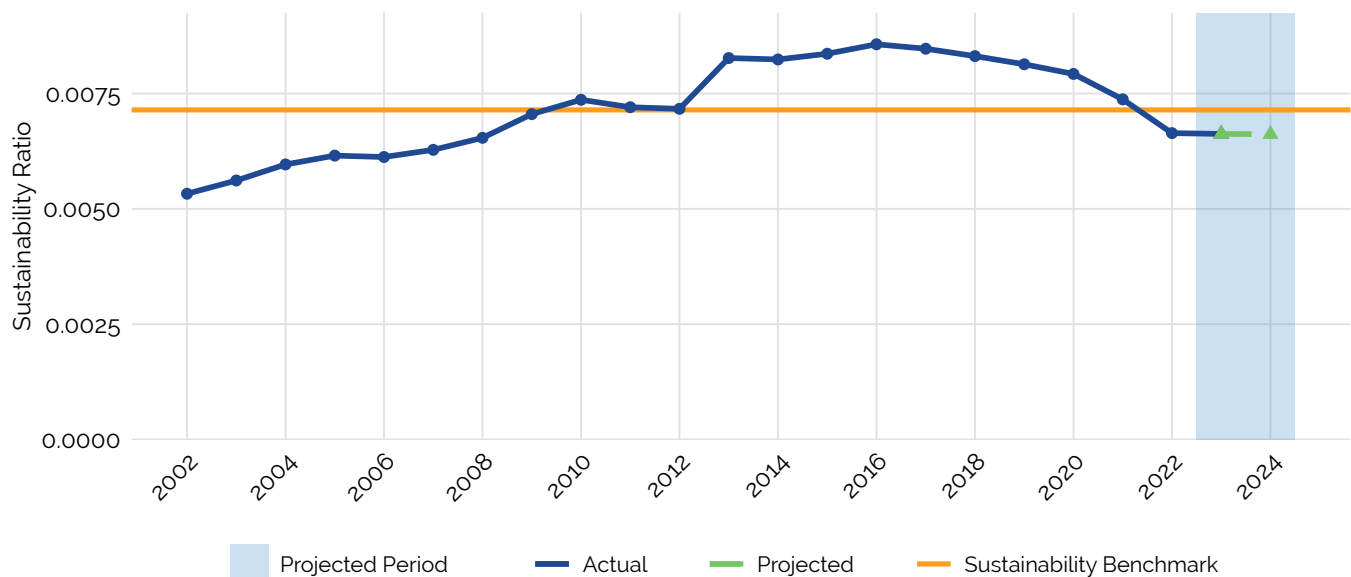
Outstanding long-term debt ÷ (Personal income × 20) | 2004–2022
