## **1. Call to Order and Welcome**

- Meeting began slightly late due to an extended Board meeting.
  - President Patrick Ho and CEO Kathy Stratton welcomed attendees.
  - Approval of May 2025 Council Meeting Minutes: Motioned, seconded, and approved unanimously.

## **2. CEO Updates – Cathy Stratton**

### **a. AMA Annual Meeting Recap**

- Strong engagement from NH delegates.
- AMA House of Delegates addressed Medicare payment cuts, vaccine confidence, and CDC integrity.
- NHMS contributed a resolution on tobacco-free generation, which passed.

### **b. Physician Health Program (PHP) Concerns**

- Board of Medicine awarded PHP contract to an out-of-state, for-profit vendor, raising concerns about data privacy, qualifications, and state oversight.
- Executive Council has tabled the decision; continued advocacy is encouraged.
- NHMS will draft a letter of opposition and seek specialty society sign-ons.
- Concerns include limited NH presence, no licensed providers in-state, and loss of data ownership.

### **c. CE Broker & Licensing Frustrations**

- Widespread complaints about clunky CE Broker system.

- Discussion on creating “how-to” resources or trainings for members.
- Suggestions for NHMS to post clear instructions online.

#### **d. Events and Membership Initiatives**

- Fisher Cats event upcoming; Patrick to throw the first pitch.
- Strong encouragement for registration to support visibility and sponsors.
- Launch of member recruitment challenge: goal of 200 new members in 2025.
- Encouraged outreach to residents and students (free membership).
- Testimonials shared for the NHMS Leadership Development Program; recruitment ongoing.

#### **e. Online Community Platform Demonstration**

- Preview of new NHMS member portal with directory, events, posts, and sponsor pages.
  - Log-in issues being resolved; further training and rollout planned.

### **3. Nominations and Leadership Opportunities**

#### **a. Open Positions and Committee Vacancies**

- Active recruitment for board, council, and committee seats.
- Names suggested: Dr. Bill Zwolak (Manchester VA), Dr. Cornell Stanciu (Addiction Psychiatry).
- Plans to issue general membership outreach for volunteers.

#### **b. Awards**

- Advocate of the Year and Lifetime Achievement Awards discussed.
  - No decision yet on legislator award due to partisanship concerns.

### **4. Committee Reports**

#### **a. Education Committee – Kirsten Singleton**

- Hospital CME reviews ongoing (5 completed in 2 years).
- Committee seeks 2–3 new members.
- Annual Scientific Conference planning well underway.
- Remaining speaker slots include opioid/substance use content and a keynote.

## **b. Membership Committee – Danielle Albushies (report via Cathy)**

- Emphasis on outreach to residents, students, and new physicians.
- Resources and talking points to be distributed.

## **c. Physician Health Committee**

- Potential name change under consideration.
- Discussion about including broader wellness themes.
- Would require bylaw update if formalized.

## **d. Bylaws Discussion**

- General consensus to avoid reopening bylaws unless essential.
  - Minor updates (e.g., committee name changes) can be brought to annual meeting for vote.

# **5. Legislative and Advocacy Update**

## **a. Overview**

- Tracked 149 bills, including criminalization of medicine, vaccines, reproductive rights, and scope of practice.
- Four major advocacy themes: protecting public health, patient-physician relationship, reproductive care, and behavioral health access.

## **b. Legislative Outcomes (Select Highlights)**

- **Opposed:** Repeal of Vaccine Association (retained); 15-week abortion ban (withdrawn); Scope of Practice Expansion (retained); CE Broker frustrations ongoing.
- **Supported:** Maternity care bills (some tabled); Mental health credentialing timelines (signed into law).
- **Concerning Items Passed or in Budget:**
  - Limiting DHHS immunization rulemaking authority.
  - ACIP overhaul by federal officials.
  - Ivermectin without prescription (status uncertain).

## **c. Future Advocacy Plans**

- Proposed NHMS statement or op-ed denouncing undermining of vaccine policy.
- Discussion on crafting language to reassure public and combat misinformation.

- Council plans to meet over the summer via Zoom.
- Open call for ideas for opioid-related speakers and nominations.
- NH Physician Magazine issue release announced.
- Recognition of council members for contributions.
