

# *2017 Legislative Report*

NH Medical Society tracked 142 bills this year, including 69 priorities, which fell into 12 categories: access to care, alcohol and tobacco, firearms, human resources, legal process, licensure, mental health, public health, reproductive health, substance use disorders, vaccines, and miscellaneous. Our success rate was just over 60% for bills we supported and just under 70% for bills we opposed, pretty good statistics for a process in which it is easier to kill a bill than get one passed and in which results are more frequently a compromise than outright victory or defeat.

Access to care was a key focus this year and improvements were made in access to medication-assisted treatment for substance use disorders, telehealth services for Medicaid patients and 3-D breast tomosynthesis. Also, an effort to prohibit the use of manufacturer coupons for prescription drug purchases was defeated.

On the legal side, NH Medical Society took the lead in defeating a bill to allow certain medical records and reports to stand on their own without live testimony from the medical provider. The stated intent of the bill was to decrease litigation costs but we believe it would merely have shifted costs from plaintiffs, who bear the burden of proof in our system, to defendants.

The backlog of severely ill mental health patients in hospital emergency departments must be resolved and NH Medical Society is involved at many levels, most visibly through its leadership of a workgroup aimed at eliminating regulatory barriers to the delivery of appropriate care and its strong support for allocation of additional resources to the mental health system. This work continues.

In the public health arena, NH Medical Society was instrumental in killing a bill that would have abolished the use of fluoride in public drinking water and in passing a bill that re-authorizes expedited partner therapy, a practice aimed at increasing the speed and flexibility of response to public health threats by allowing providers to prescribe drugs for non-patient sexual partner(s) of a patient in limited circumstances.

NH Medical Society was mostly successful in its advocacy on reproductive health issues; however, defeat came on a very public and politically-charged bill. On the plus side, we helped kill proposals to undo carefully-crafted restrictions on the authority of midwives to perform vaginal deliveries after C-sections and to ban abortion after viability, and we helped pass a study commission bill to explore improved access to oral contraceptives by making them available through pharmacies without a prescription. On the negative side, our efforts to kill or improve a fetal homicide bill failed and the bill was enacted with a 20-week threshold for defining a fetus as a person in the criminal code. A similar bill was retained in a House committee and we hope to make changes to this new fetal homicide law next year.

While our efforts to prevent expansion of the medical conditions for which therapeutic use of cannabis is authorized and to preserve a two-step system for use determinations failed, a bill to authorize needle exchange programs in New Hampshire, which we supported, has been signed into law.

NH Medical Society was not successful in preventing expansion of the list of vaccines that may be administered to adults by pharmacists. However, we were a key advocate in maintaining the requirement of the Hepatitis B vaccine for children in schools and childcare settings. Childhood vaccines are a vital component of public health protection in our state and our efforts to prevent changes to this program were strongly and actively supported by members.

## Access to Care

### **Process Established to Deal with ACA Reform and Insurance Market Stabilization (HB 469)**

In anticipation of federal repeal or reform of the Affordable Care Act, HB 469 establishes a multi-level approach to planning led by the Insurance Commissioner and aimed at stabilizing premiums in the individual insurance market. Planning is to include public notice, hearing and comment period, and involve the Governor, Joint Healthcare Reform Oversight Committee, and Board of Directors of the NH Individual Health Plan Benefit Association. The Insurance Commissioner has already initiated this process once, seeking feedback on a proposal to set up a risk subsidy mechanism in the individual market funded by an assessment on the entire marketplace. The proposal was rejected by the Joint Healthcare Reform Oversight Committee and did not move forward beyond that.

### **Frequency of Prior Authorization for MAT Limited to Once Every 12 Months (SB 158)**

SB 158 declares that if substance use disorder services are a covered benefit under a health benefit plan, a health carrier that has authorized or approved medication-assisted treatment for such services shall not require renewal of prior authorization more frequently than once every 12 months.

### **Medicaid Coverage for Telehealth Services Extended to Metropolitan Areas (SB 237)**

SB 237 allows medical providers who practice in metropolitan areas to be reimbursed by Medicaid for telehealth services.

### **Proposal to Allow Self-Ordered Lab Tests Rejected (HB 256)**

HB 256 would have authorized a person to self-order lab tests without a health care provider's request and imposed certain mandates on any lab reporting test results directly to individual patients. The bill would also have limited a health care provider's duty of care

to a patient in this circumstance. NHMS opposed authorization of self-ordered lab tests in the absence of rigorous state requirements for proficiency testing of laboratories conducting the tests.

### **Legislature Allows Continued Use of Drug Manufacturer Coupons to Lower Out-of-Pocket Costs for Patients (HB 443)**

HB 443 would have prohibited prescription drug manufacturers from offering to pay or reimburse an individual for his or her insurance copayment related to drug therapy. Many patient advocacy groups rose in opposition to the bill citing increasing out-of-pocket costs associated with medications, even when covered by insurance, and the importance of affordability to drug therapy adherence.

### **Effort to Repeal Medicaid Expansion Program Thwarted (HB 638)**

HB 638 would have repealed the NH Health Protection Program, also known as Medicaid expansion, which provides health insurance to approximately 50,000 low-income citizens not eligible for traditional Medicaid coverage. Although this bill was killed, Medicaid expansion remains under scrutiny. It will require legislative reauthorization by the end of 2018 and questions persist regarding sustainable funding for non-federal costs and whether the program is working to reduce overall healthcare costs. Provider groups, including NHMS, support Medicaid expansion and its continuation into the future.

### **Mandatory Insurance Coverage for 3-D Mammography Still Under Consideration (SB 189)**

SB 189, a bill requiring insurance coverage for 3-D tomosynthesis mammography, was re-referred to the Senate Commerce Committee and will be taken up again this fall and in early January. The bill stalled in committee because significant progress toward coverage of this service was being made voluntarily; however, it remains viable should the coverage

problem not be sufficiently resolved within a reasonable timeframe.

### Human Resources

#### **House Labor Committee Takes Longer Look at Family and Medical Leave Proposal (HB 628)**

HB 628 seeks to establish a system of paid family and medical leave insurance modeled on the state's successful model for unemployment insurance. The bill intends a voluntary program, not a mandate, aimed at keeping workers in the state and helping small businesses compete with larger ones for those workers. There seemed to be a fair amount of support for providing family and medical leave but also significant differences of opinion as to the details; so, the bill was retained in the House Labor Committee for further work.

### Legal Process

#### **Evidentiary Rules re Medical Evidence Remain Unchanged (SB 163)**

SB 163 would have allowed certain medical evidence to be introduced in writing, without the physical presence of the physician or dentist offering it, in civil cases involving claimed medical expenses of \$25,000 or less and subject to the court's discretion. While this may sound like a good cost-saving mechanism in smaller cases, NHMS counsel testified that parties to litigation already voluntarily agree to do what the bill envisions when the medical records are very clear. In the remaining more difficult cases, the bill would not accomplish its intended purpose of expediting judicial process. Instead, it would merely shift the cost of producing the live witness from the plaintiff, who bears the burden of proof in our system, to the defendant.

### Licensure

#### **Physician Survey Now Linked With State Licensure Process (HB 322)**

HB 322 seeks to improve the data available for state

healthcare planning by linking the NH Division of Public Health Services' Physician Survey to state licensure by the Board of Medicine and other regulatory entities. Under this bill, individual participation in the survey remains voluntary; however, the survey system as a whole switches from "opt-in" to "opt-out." The hope is that this shift will lead to improved participation rates and more reliable data. NHMS members are encouraged to complete the Physician Survey when it is offered. The survey is electronic and should take only 3 to 15 minutes to complete.

### Mental Health

#### **State Leaders Tackle Mental Health Crisis, Particularly Long-Term Stays in Emergency Departments (HB 400)**

HB 400 is a comprehensive piece of legislation that seeks to make short- and long-term changes in the mental health delivery system to alleviate demand for NH Hospital beds and shorten wait times for those who require admission to the hospital, particularly for involuntary admission patients who are backed up in emergency departments throughout the state. The bill works hand-in-hand with task force meetings led by Governor Sununu, workgroups led by DHHS Commissioner Jeff Meyers, NHMS, and others, and legislative work on other bills. Funding, regulatory barriers, and special logistic and legal requirements present significant challenges but the commitment to improve this situation is far reaching and remains strong. In its final form, HB 400 requires the Department of Health and Human Services to develop a 10-year plan for mental health services, to deal with the due process rights of persons subject to involuntary admission, and to look at using the Philbrook Center as a children's mental health facility. More immediate resolutions, such as funding additional designated receiving facility, transitional and peer crisis beds, establishing additional mobile crisis teams, and developing an integrated data management system for real time data regarding system demand and capacity, were moved from HB 400 to the budget bills (HB 144 & HB 517).

**Bill to Extend Involuntary Admission Process to Substance Use Disorders Re-Referred to Senate Committee (SB 220)**

SB 220 seeks to change the definition of mental illness for the purpose of involuntary commitment to include ingestion of opioid substances. The intention of the bill, to facilitate treatment for persons with severe addictions, is good. However, NH Hospital cannot meet the current demand for beds.

Additionally, and perhaps more importantly, NH Hospital is not set up to provide the medical services that are often necessary for individuals requiring detoxification and other acute treatment for substance use disorders.

**Study of Balance Billing to Begin in Mid-September (HB 329)**

HB 329 establishes a committee consisting of four House members and one Senate member to study the practice of balance billing by health care providers for services received by an insured person at an in-network health care facility. Members of the committee have been appointed and the group will organize in mid-September and file a report on or before November 1<sup>st</sup>. The NH Insurance Department supports substantive legislation dealing with balance billing (in fact, it may request legislation this session regardless of the conclusions of the study committee) and NH Hospital Association encouraged consideration of the NAIC (National Association of Insurance Commissioners) Model Act during the hearing on HB 329. This bill raises issues of government rate-setting and interference with private contracting, as well network adequacy. No local consumer complaints related to balance billing have been brought forward and the need to address this complex issue through legislation is not clear.

**Committee Established to Study Helmet and Restraint Laws for Youth Operators and Passengers of OHRVs and Snowmobiles (HB 237)**

A five member legislative committee has been

established to study helmet and restraint laws for youth operators and passengers of OHRVs and snowmobiles. Committee members have been named, will meet this fall, and will file a report on or before November 1<sup>st</sup>.

**Commission Established to Study Environmentally Triggered Chronic Illness (HB 511)**

A twelve member commission has been established to study environmentally-triggered chronic illness. The group is comprised of legislative and non-legislative members, including a representative of NHMS. It will meet until November, 2018 and will file two reports during that time. The group has already organized and decided to focus first on three of its 12 duties: define, by codes, the health status indicators to be monitored including chronic conditions, medical conditions, and poor health outcomes; study current health databases, including years available, potential for small area analysis, and privacy concerns; and research currently existing health data reports by agency, bureau, or organization. All 12 duties are listed in the bill.

**Bill to Abolish Fluoridation in Water is Tabled in House and Unlikely to Move Forward (HB 585)**

HB 585 seeks to prohibit the introduction of fluoride into the state's drinking water. The bill was laid on the table in the House after receiving a 19-1 committee recommendation that it be killed. A subsequent effort to remove the bill from the table failed by a vote of 78-267 and indicates a low level of support for this proposal.

**Expedited Partner Therapy Authorized to Assist in Control of Public Health Threats (SB 222)**

SB 222 states that a health care professional authorized to prescribe medication for the treatment or prevention of a communicable disease may prescribe, dispense, or distribute directly or by standing order, an antimicrobial medication to a patient he or she did not evaluate and with whom

there is no established health care provider-patient relationship to empirically treat for, or provide prophylaxis to prevent, a communicable disease that poses a threat to public health. Communicable diseases that pose a threat to public health shall be limited to Bordetella pertussis, Chlamydia trachomatis, Neisseria gonorrhoea, and Neisseria meningitidis or additional diseases identified by the Commissioner of Health and Human Services in order to control a disease outbreak.

### **Reproductive Health**

#### **Fetal Homicide Bill Passes with 20-Week Threshold for Defining a Fetus as a Person in the Criminal Code (SB 66)**

SB 66 includes fetus in the meaning of “another” for purposes of first degree murder, second degree murder, manslaughter, negligent homicide, and causing or aiding suicide but not for purposes of capital murder. The bill defines fetus as an “unborn offspring, from the embryo stage which is the end of the twentieth week after conception or, in the case of in vitro fertilization, the end of the twentieth week after implantation, until birth.” It exempts from the impact of this change any act committed by or at the request or direction of, or for the benefit of, the pregnant woman; any act performed by a medical professional in the course of professional duties including the termination of pregnancy; and any act taken in furtherance of the lawful dispensation or administration of medication. Notably, the bill does not make any reference to viability; however, the majority report in support of the bill does make such a reference and could create confusion. A second fetal homicide bill, HB 156, is retained in the House Criminal Justice & Public Safety Committee and we hope to clarify some of this in the context of that bill.

#### **Commission Established to Study Pharmacy Access to Oral Contraceptives (HB 264)**

HB 264 establishes a nineteen member commission to study allowing pharmacists to prescribe or make available by protocol oral contraceptives and certain related medications. NHMS is generally supportive of this idea but has concerns related to expansion of

prescribing authority to pharmacists and the potential for this change to increase, rather than reduce, out-of-pocket costs for contraceptives. Two members of the commission are appointed by NHMS, and at least two other physicians will also serve as members. The group will convene in September and file a report on or before December 1<sup>st</sup>.

#### **Bill To Ban Abortion After Viability Tabled in House and Unlikely to Move Forward (HB 578)**

HB 578 would have prohibited abortion of a “viable unborn child” except in cases of medical emergency and would have defined viable as “that stage of fetal development when the life of the unborn child may be continued indefinitely outside the womb by natural or artificial life-supportive systems.” A strong majority of House members voted to table the bill after a committee-recommended amendment failed by only nineteen votes, and it unlikely to move forward. NHMS opposed the bill due to its interference in decision-making best left to the patient and her health care provider.

### **Substance Use Disorders**

#### **Program Allowing Therapeutic Use of Cannabis Expanded (multiple bills)**

Twelve bills were introduced proposing changes to the law regulating therapeutic use of cannabis. Most sought to add new medical conditions to the list of those for which therapeutic use of cannabis is allowed. Up till now, a two-step process was in place which required that a patient have a listed medical condition and a qualifying symptom in order for cannabis to be used. The bills took varying approaches with some adding a new condition “above the line” so that a qualifying symptom would still be required along with the newly-added diagnosis, others adding a new condition “below the line” so that only the condition would be required, and the remainder adding a condition along with language eliminating or making an end run around the two-step process entirely. In the end, the following conditions were added: moderate to severe chronic pain (below the line), severe pain that has not responded to previous treatment (below the line), Hepatitis C

regardless of whether or not the person is currently receiving anti-viral treatment (change to language above the line), moderate or severe PTSD (below the line), Ehlers-Danlos syndrome (above the line), and any condition that has resulted in one or more of the qualifying symptoms (above the line but basically eliminates the need to have a specific qualifying medical condition). Opioid addiction, fibromyalgia, and myelitis disorder or disease were not added but could be covered under moderate to severe chronic pain or some other new language in the statute.

### **Needle Exchange Bill Enacted in Face of Opioid Epidemic (SB 234)**

SB 234 exempts residual amounts of controlled substances in hypodermic syringes and needles from the provisions of the Controlled Drug Act, authorizes persons other than pharmacists to dispense hypodermic syringes and needles and allows them to be sold in retail establishments other than pharmacies, and authorizes the operation of syringe service programs in New Hampshire. The bill had overwhelming support, including the support of NHMS, in the face of the ongoing battle against opioid addiction and overdose deaths.

## **Vaccines**

### **Legislature Rejects Effort to Eliminate Hepatitis B from the List of Mandatory Vaccines for Children (HB 362)**

An effort to remove Hepatitis B from the list of vaccines required for children in schools and childcare settings failed this session and the bill seeking to do so, HB 362, was amended to contain benign language making no substantive change to the current program. Childhood vaccines are a vital component of public health protection in our state and NHMS strongly supported the amended version of HB 362 over the original. NHMS also opposed a related bill, HB 361, seeking to limit the authority of the Department of Health and Human Services with regard to the vaccine program. That bill was killed.

### **Pharmacists Authorized to Administer Additional Vaccines to Adults (HB 469)**

HB 469 adds Hepatitis A, Hepatitis B, Tdap, MMR, and meningococcal vaccines to the list of vaccines that may be administered by a licensed pharmacist to adults provided the pharmacist holds a current NH license, possesses at least \$1 million of professional liability insurance coverage, has completed specific training related to these vaccines, provides evidence of the above three conditions to the Pharmacy Board, provides notice to the PCP when designated by the patient, and maintains records of administration for each individual as required by state and federal law. This was originally proposed as SB 65, sponsored by Sen. Bob Giuda, however that bill passed with a drafting error related to vaccine administration by pharmacy interns and it was nullified and replaced by an amendment to HB 469. Pharmacy interns are now authorized to administer influenza vaccines to the general public and pneumococcal and varicella zoster vaccines to adults provided certain criteria are met. They are not authorized to administer vaccines on the expanded list contained in HB 469 and listed above.
