  - Motion to allow Dr. Dong on the council; unanimous yes, no neigh, no abstain
- 2. Update from the interim CEO Jane Tewksbury. Building closing 12/28/23. Plan to move to Two Capital Plaza end of January. One position has been eliminated due to budget constraints.
- 3. Ava's presentation on Legislative Priorities. Ava Hawkes introduces herself.
  - a. Advocacy update Ava has attended National, State and Local Conferences.
  - b. Hospital Med staff updates: Exeter Hospital, Speare Memorial Hospital, Dartmouth Hitchcock Pediatrics Residents and Faculty, Geisel School of Medicine
  - c. Partnerships with community partners, Cannabis Policy Coalition
  - d. Legislative update
    - i. LSR Legislative Service Request LSR) House members CANNOT file an LSR confidentially, but Senate members CAN
    - ii. House Bill (HB) begins in the House; has to have a prime sponsor
    - iii. Senate Bill (SB)
    - iv. CACR Constitutional amendment concurrent resolution: 3/5 majority in both the House and Senate
    - v. HCR or SCR House or Senate Concurrent resolution
    - vi. Biennium duration of one legislative term
    - vii. Crossover this year deadline is Thursday April 11, 2024
  - e. As of 12/1/23 House 198 R, 195 D, 3 Independents; Senate 14 R, 10 D
  - f. 1200 LSRs filed in addition to the 300 bills that were retained or re-referred
  - g. NHMS Feasibility Impact Metric: Recommendation for 3-5 top priorities
    - i. Legislation to prioritize vs legislation to weigh in on.
    - ii. Priorities: Reproductive rights, transgender health, gun reform, prior authorization, cannabis legalization, healthcare workforce
  - h. Ava is the registered lobbyist for the NHMS; Catrina is the registered lobbyist for certain specialty societies.
- 4. Will establish a NHMS Google drive to access up to date spreadsheets and policies.

- 5. Physician burn-out pilot through the NMHS through Penni Perry at a lower rate than she would otherwise charge. Total 7 sessions for the pilot program. Propose to continue to program. Provide space, snacks, technology, zoom, advertising.
  - a. New model starts 1/4/2024: 12 modules of learning with 12 sessions delivered weekly or every other week.; 4-10 physicians; 3 individual sessions, through the Medical Society it would afford 16 hours of CME.
  - b. Motion for budget neutral proposal to continue to offer the program. Approval by acclamation
- 6. Legislative Committee needs to be established.
