Featured Focus: Mid-Year Legislative & Regulatory Report

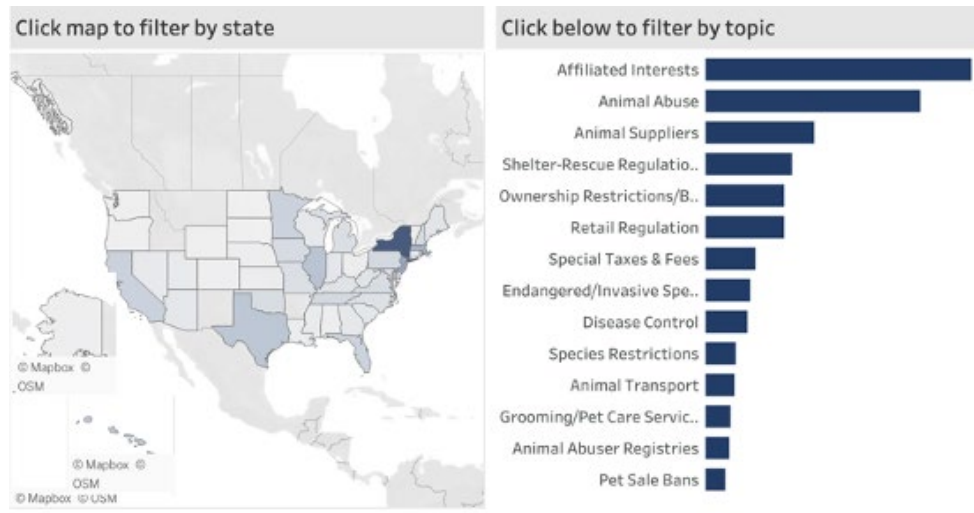
