Search steps and timeline for a permanent ED

Johnathan reported on his conversation with Joy Lin from CPB. Discussion about a timeline. Is it unreasonable to aim for naming a new ED by Sept. 1. If we open up the search before the conference, Terry could be available to answer questions. Possibly having a search committee named earlier than that. We could include board members and non-board members on the committee. Gabrielle suggests we hire someone to help with the search in addition to having a search committee. Terry reported that John Barth, Margurite Nutter and Flo Rogers are all doing some of that work (through Livingston & Associates and on their own). Gabrielle – it sends a message to outsiders that we're taking this seriously. LaToya – also looking at this from a DEI aspect, it's better to have someone recruiting. Terry suggests that Livingston is a good place to start. Brent – I think it's a good idea, but I haven't seen them manage the administration part of a search. Someone outside of Livingston might be more likely to handle those admin pieces.

Step 1 – get some price quotes from recruitment/administration companies

What is the timeframe people think we could aim for having a new ED named? Gabrielle – I'm cautious about a final timeline, but would be comfortable with an opening date and a closing date for taking applications.

Suggestion: Gabrielle suggests we should be able to have a June/July/August opening. She suggests 60 day opening. LaToya – I'd like to see us open the search before the conference. Johnathan: Would we be comfortable with June 1 or June 15? Preference is for June 1.

Gabrielle has offered to interview Terry to record and play at the conference.

Brent: Question about who gets quotes. Christine can do that and then pass it off to a board member.

Brent moves that Terry & Christine get quotes from some search firms with the intention of opening the search in early June. Seconded by LaToya. Motion carries.

## Quote from Suzanne Meyer

- Conference (recommend approving this piece) Gabrielle moves that we engage Suzanne for the conference at the rate quoted. Seconded by Reggie. Motion carries.
- Communications (recommendation that we look for an intern to take on our social media and communications on a temporary basis). Gabrielle suggested she is willing to do the communications piece in the interim. We also could maybe look into an internship.

## Holes in the conference agenda

- Main session on Wednesday (need ideas and suggestions for a main session here) Ideas: The role of freelancers in public media (including the editor corps), Editor Corps lessons learned, A mentorship session. Christine and Brent will put together a session around freelance and editor corps.
- Speaker registrations (Christine will provide an updated list of all speakers who have registered so everyone can nudge those who have not yet registered)
- We also have a number of sessions without panelists...as you add those, please notify Christine so she can get them put into Socio.

Bylaws Voting (April 14 for 24 hours) – All set to have the voting happen next week.

Editor of the Year Nominations - deadline is Friday night. The board will need to review the nominations and make a decision. Can we do this via Slack, or does the board want to hold a special meeting?

Brent suggested that we set another meeting to review proposals for a search firm and EOY nominations. April 22 at 1:15 Eastern time.

Other business: Christine suggested to the board that in the search process if they are considering hiring someone else as ED that she be included in the process in some way.
