





# Biosketches



## **Maxine A. Papadakis, MD**

**Professor of Medicine, Emeritus, UCSF and a practicing internist  
San Francisco Veterans Administration Medical Center**

Maxine A. Papadakis, MD is a UCSF Professor of Medicine, Emeritus. She was the Associate Dean for Students in the School of Medicine at UCSF and a leading investigator in the field of professionalism. In a series of ground-breaking studies in collaboration with the Federation of State Medical Boards and the American Board of Internal Medicine, Dr. Papadakis linked long term outcomes of disciplinary action against physicians by licensing boards to performance of physicians during their training. She further advanced the field by describing the types of unprofessional behavior that are linked with disciplinary action. Dr. Papadakis is the recipient of numerous awards, including the John P. Hubbard Award from the National Board of Medical Examiners and the Distinguished Alumni Award from the University of Cincinnati College of Medicine. She is also an editor on the annually published *Current Medical Diagnosis and Treatment*. Upon her retirement from UCSF, the School created the Maxine Papadakis Awards to recognize faculty who are exemplars in treating students and all others in the clinical environment with professionalism, courtesy and respect.



## **David P. Sklar, MD**

**Distinguished Professor, Department of Emergency Medicine & Internal Medicine  
UNM School of Medicine**

Dr. David Sklar is a Professor in the College of Health Solutions and Advisor to the Provost at Arizona State University and Editor in Chief of Academic Medicine. He is also Distinguished Professor and Associate Dean Emeritus at University of New Mexico where he was a Chair of Emergency Medicine, Associate Dean and DIO for Graduate Medical Education and Associate Dean for Clinical Affairs.

Dr. Sklar received his medical degree at Stanford University and did an internal medicine residency at the University of New Mexico and an emergency medicine Fellowship at the University of California in San Francisco. He was on the faculty of the school of medicine at the University of New Mexico for 37 years teaching, providing patient care and doing research.

His main areas of interest in research have concerned injury prevention, medical education, health policy and ethics. He is particularly interested in how medical education can transform the health care delivery system to provide better health and lower costs. He has published over 200 hundred articles in the medical literature as author or co-author.

He served in the Senate Finance Committee as part of an RWJF Health Policy Fellowship in 2011 and 2012 and worked on the Affordable Care Act, physician payment and graduate medical education. Upon completion of the fellowship, he was chosen as Editor in Chief of Academic Medicine, the leading journal in health professions education.



## **Alison Whelan, MD**

**Chief Medical Education Officer  
Association of American Medical Colleges (AAMC)**

As Chief Medical Education Officer, Alison J. Whelan, MD, leads AAMC initiatives to transform the current models of education and workforce preparation across the full continuum of medical education. She also directs AAMC efforts that support medical education officers, regional campuses, education researchers, students, and residents. Prior to joining the association in 2016, Dr. Whelan had been a member of the faculty at Washington University School of Medicine since 1994. In 1997, she was appointed associate dean for medical student education and in 2009 was appointed senior associate dean for education. During her tenure, Dr. Whelan coordinated the creation of the Practice of Medicine curriculum and led the planning for the school's new education building and the creation of the Center for Interprofessional Education. Dr. Whelan received her bachelor's degree from Carleton College in 1981. She earned her medical degree from Washington University in 1986 and completed her postgraduate work and residency at the former Barnes Hospital, now Barnes-Jewish Hospital.


