<sup>(b)</sup>Health Coverage may be added for Preapprentices at any point.

\*There is no minimum or set Total Package for Preapprentices, but employers must make any applicable contributions to the Industry Fund, Health Fund and Organizing Fund.

The Total Package will increase \$2.80 on June 2, 2025, and an additional \$2.80 on June 1, 2026.

The current IRS mileage rate is \$.67 per mile.
