# **About the Board of Directors**

Board members represent themselves as working professionals in the fields of sustainable procurement, responsible sourcing, supplier diversity, supply chain management and other disciplines related to the mission of the SPLC.

Board members do not represent nor advocate for their organizations per se in Board discussions or deliberations.

That being said, SPLC values Board members' perspective based on their professional roles – on the needs and insights of procurement professionals, on the developmental status of the professions they represent, and on specific initiatives and trends they may see in the industry segment or sector they work in.

## **Roles & Responsibilities**

- Prepare for and conscientiously participate in all Board and committee meetings, including appropriate organizational activities when possible. Meetings are held quarterly, 3 virtual per year, 1 in person (1.5 days).
- Actively engage in at least 1 Board committee and volunteer outside of Board role when appropriate. Most committees have 5-6 virtual meetings per year (typically 1 hour in length).
- Understand and embrace fiduciary responsibilities. Review financials and give feedback on financial strategy and revenue opportunities and help increase revenues: recruit new members, identify funding opportunities.
- Act as an ambassador for the organization when in public, speak with one voice outside of Board room.
- Propose and help structure partnerships.
- Suggest possible nominees for Board membership who would make significant contributions to the Board and organization.
- Follow trends in the organization's field of interest and keep informed. Engage actively in Board conversations and consultations around organizational strategy, bringing your perspective on the field of responsible procurement and needs of its practitioners to such organizational strategy development.
- Know the organization's mission, purpose, goals, policies, programs, services, strengths, and needs.
- Any significant matters coming to you individually should be called to the attention of the Chief Executive
  Officer and/or the Board's elected leader as appropriate. Follow appropriate protocol in addressing Board
  matters and ensuring the staff leadership (CEO) of all day to day matters.



# **Committees**

#### **Executive Committee**

Led by the current Board Chair, the Executive Committee comprises key officers including the Vice Chair, Immediate Past Chair, Treasurer, Secretary, and the President/CEO. This committee exercises the authority delegated by the full Board, reporting all decisions and recommendations back to them. In addition to fulfilling duties outlined in the Bylaws, the Executive Committee is responsible for appointing members to other Board-level Committees and Technical Advisory Groups.

#### **Board Committees**

#### Revenue, Finance, and Audit

Chaired by the Treasurer, this committee supports the Treasurer and President/CEO in developing revenue strategies and managing the organization's finances. It is responsible for making recommendations on financial matters to the full Board. Additionally, the committee solicits and reviews financial audit reports, as appropriate, and reports the findings to the Board.

#### Membership & Outreach

This committee is responsible for developing and implementing strategies to grow and engage the organization's membership. It collaborates with staff on outreach and marketing initiatives, while also periodically reviewing the member dues structure to ensure it aligns with market value. Additionally, the committee assists staff with various outreach and membership engagement tasks as needed.

#### **Governance & Board Development**

This committee periodically assesses the Board's collective expertise against the organization's evolving needs and collaborates with the Chair and President/CFO to draft comprehensive Board development strategies. The committee then makes recommendations for Board development and recruitment to the full Board, subsequently implementing approved decisions. Additionally, it regularly reviews SPLC's governance procedures to ensure they effectively support the mission and recommends necessary changes to the Board.membership engagement tasks as needed.

#### **Advisory Committees**

#### **Technical Advisory Committee**

The Technical Advisory Committee (TAC) provides expert guidance to the SPLC Management Team and Board on the technical aspects of the Council's programs and related work products. It also offers review and oversight for any necessary Working Groups, such as the SP Assessment Working Group, that support SPLC program offerings. Composed of technical subject matter experts appointed by the SPLC Executive Team, TAC members may or may not be existing Member representatives.

#### **Strategic Advisory Committee**

The Strategic Advisory Committee (SAC) serves as an expert sounding board for the Council's overall strategy. Comprised of subject matter experts appointed by the SPLC Executive Committee, SAC members offer informal guidance on the Council's work. These invited members may or may not be existing Member representatives, ensuring a diverse range of perspectives. appropriate, and reports the findings to the Board.



# Joining the Board of Directors

Members of the Board of Directors are expected to be highly engaged fiduciaries and ambassadors for SPLC. This includes diligently participating in quarterly Board meetings and at least one committee, understanding and fulfilling financial oversight responsibilities, and actively helping to increase revenue through recruitment and identifying funding opportunities. Directors are also tasked with acting as unified public representatives, proposing partnerships, suggesting future Board nominees, and staying informed on industry trends to contribute to organizational strategy.
