The SPR will utilize Alliance Nationwide Exposition as the official Exhibitor Appointed Contractor for the 2026 International Pediatric Radiology (IPR) Congress.

All arrangements should be coordinated through Alliance Nationwide Exposition and the SPR. It is important to know that the Hotel will not accept any shipments, so you must arrange your shipping needs through the Exhibitor Appointed Contractor.

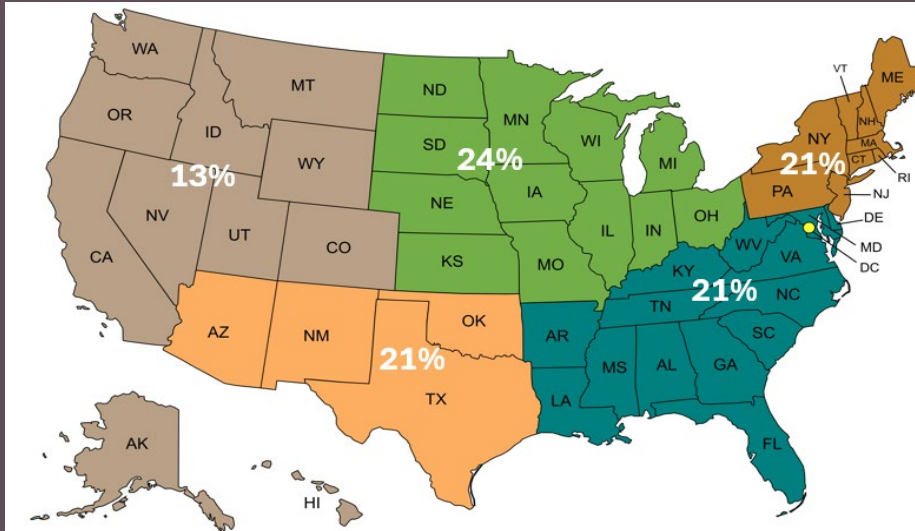

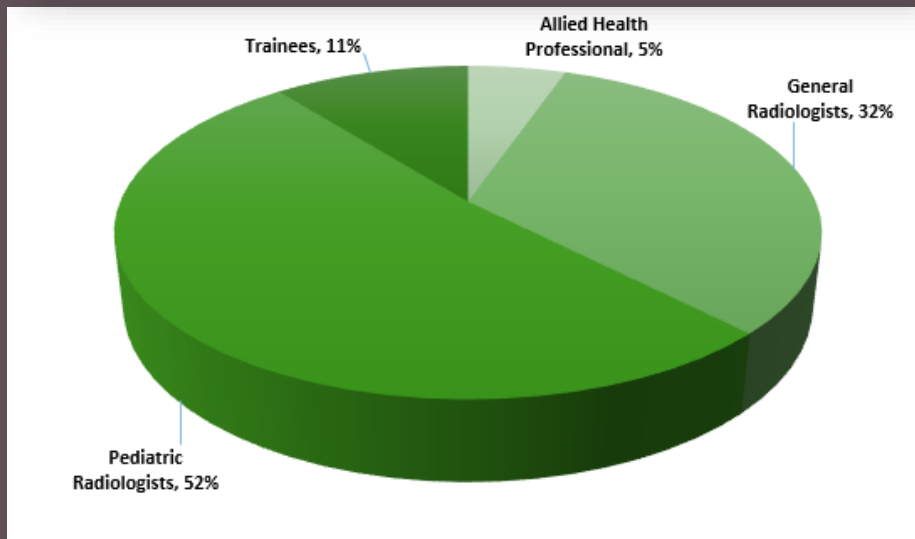

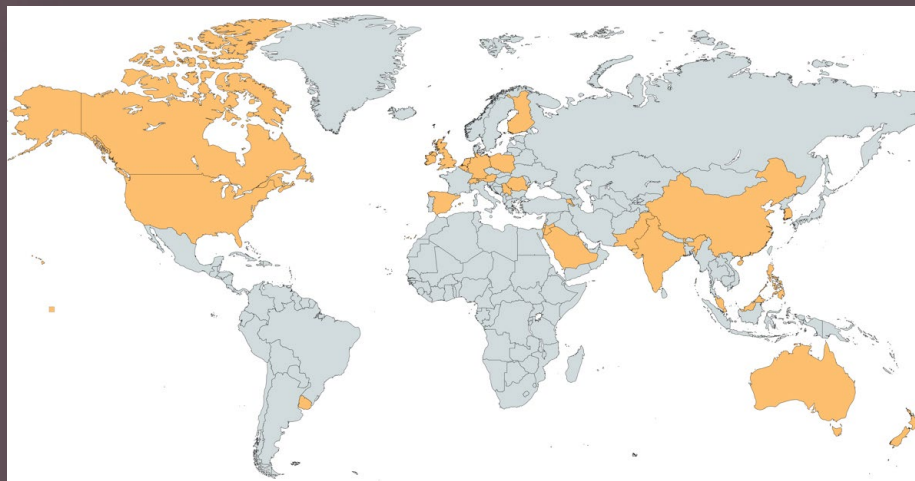

# RULES & REGULATIONS

All exhibits must conform to and enhance the professional, educational, and instructional atmosphere of the meeting.

1. Exhibit space will be allocated on a first-paid, first-served basis. Priority will be determined by date of receipt of application for space accompanied by required payment.
2. Application for space must be accompanied by the full fee to guarantee reservation. All payments must be received by May 1, 2026. Reservations made after May 1, 2026, must be followed by payment within two (2) working days. Unpaid exhibit reservations will be released for general sale. Exhibiting/sponsoring company will remain responsible for payment of space. Terms are enforced regardless of whether the sponsor/exhibitor does not attend, fails or elects not to participate in conference, or if exhibit space is resold due to notification of absence. No refunds.
3. The standard exhibit space is one (1) 6'x30" table, unless stated or marked otherwise on the floor plan or in the exhibitor prospectus. The exhibitors must supply material that will fit within the assigned space. All tables will be approximately 3 feet from the wall and there will be approximately 3 feet between each table. All exhibits/tabletops must fit within the confines of their assigned space so as not to impede traffic flow, infringe on the space of other exhibitors, or violate the emergency exit routes set forth by the fire marshal.
4. No exhibitor shall assign, sublet, or share the whole or any part of the space contracted to them. Exhibitors agree to limit the service and/or materials displayed in their exhibit area to those purveyed by the exhibitor, with the exception that other proprietary equipment may be used solely for the purpose of demonstrating the materials or services of the exhibitor.
5. Any other booth furnishings and equipment must be contracted through the official exhibition service contractor or the hotel/convention center, as indicated in the exhibitor's service kit.
6. SPR reserves the right to impose limitation on noise levels and any other method of operation which becomes objectionable. Any distribution of literature or samples shall be limited to the exhibitor's assigned space. Exhibitors may not interfere with collateral that is not produced by said exhibitor. Violation of this will result in cancellation of exhibit space during show without refund.
7. SPR reserves the right to rearrange the final floor plan based on unsold or unoccupied exhibit space. Space shall be of equal or greater value and specifications. In said event all exhibitors will be notified in writing, prior to the event.
8. In the event that no representative of an exhibiting organization has claimed its space by 6:30 a.m. Eastern Standard Time on June 1, 2026, SPR has the right to relocate the exhibit space.
9. If SPR should be prevented from holding the exhibition for any reason beyond SPR's control (such as, but not limited to, damage to the building, riots, strikes, epidemics, pandemics, acts of government, or acts of God) or if an exhibitor cannot occupy the assigned exhibit space due to reasons beyond SPR's control, then SPR has the right to cancel the exhibition or any part thereof, with no further liability to the exhibitor other than a refund of exhibit space fee.
10. The exhibitor shall be liable to the host facility and/or SPR for any damage to the building and/or the furniture and fixtures contained therein, which shall occur through acts or omissions of the exhibitor.
11. No photography is allowed without the permission of the booth staff and/or show manager. Such permission shall not be unreasonably withheld.
12. Exhibitor Responsibility Clause: To the fullest extent permitted by law, the person/legal entity described as "Exhibitor" in this clause and in this exhibitor contract hereby assumes full responsibility and agrees to indemnify, defend and hold harmless Hilton Boston Park Plaza ("Hotel") and Hotel's owners, managers, subsidiaries, affiliates, employees and agents (collectively, "Hotel Parties"), as well as The Society for Pediatric Radiology ("Group"), from and against any and all claims or expenses arising out of Exhibitor's use of the Hotel's exhibition premises. Exhibitor agrees to obtain and maintain during the use of the exhibition premises, Comprehensive General Liability Insurance, including contractual liability covering the Exhibitor's indemnity obligations in this clause. Such insurance shall be in the amount of not less than \$1,000,000 combined single limit for personal injury and property damage. The Hotel Parties and Group shall be named as additional insureds on such policy, and Exhibitor shall supply the Hotel with a Certificate of Insurance at least 30 days prior to the use of the exhibition premises. The Exhibitor understands that neither the Group nor the Hotel Parties maintain insurance covering the Exhibitor's property and it is the sole responsibility of the Exhibitor to obtain such insurance.
13. Exhibitor Health and Safety Protocols: Exhibitor acknowledges that it is solely responsible for its personnel's well-being. Therefore, Exhibitor accepts the risk of being exposed to, contracting, and/or spreading any communicable disease such as COVID-19 to attend SPR's meeting. Exhibitor acknowledges that it and its personnel who attend SPR's meeting must comply with the applicable health and safety laws and regulations of Boston. Exhibitor also agrees to comply with any health and safety measures that Hotel and SPR may adopt, including those that Hotel and SPR issue after Exhibitor signs, initials, and returns this document. Exhibitor agrees that its failure to comply with such laws, regulations and measures may result in SPR excluding it from the meeting.

# RULES & REGULATIONS

## Badge Policy

All participants affiliated with exhibits must be registered. Each person will be issued an exhibitor badge and must be employed by the Exhibitor or have a direct business affiliation. Each company is allotted up to 2 badges per one 6'x30" tabletop exhibit space purchased. Badges entitle exhibitors to attend the educational sessions for education credits and social events included in the exhibitor package purchased. Additional registrations for the meeting and social events may be made by paying the appropriate non-member fees.

## SPR Meeting and Social Event Code of Conduct

All exhibit personnel are expected to review and uphold the SPR Meeting and Social Code of Conduct. Personnel in violation will be asked to leave the function, or additional action will be taken as outlined in the document, accessible [here](#).

## Security

No security guard will be provided in the exhibit space. The space will be secured by a restricted lock. The safekeeping of all exhibitor/sponsor property shall remain the responsibility of the exhibitor and/or sponsor.

SPR and Hilton Boston Park Plaza will not be held responsible for any lost, stolen or damaged exhibitor/sponsor property.

## Agreement Terms

All terms are non-cancelable. All terms and conditions of the 2026 International Pediatric Radiology (IPR) Congress are agreed upon and enforced by company signature. Company must agree to pay for the assigned exhibit space in accordance with the guidelines contained in the SPR Exhibit Contract Terms. Company must agree to abide by all provisions set forth in these terms as a part of this contract between The Society for Pediatric Radiology and the exhibitor/sponsor. Terms are enforced regardless of whether the sponsor/exhibitor does not attend, fails or elects not to participate in conference, or if exhibit space is resold due to notification of absence. No refunds.

## Payment Terms

Payment is due upon receipt of invoice from SPR or upon signature of this agreement. Exhibit Space assignment is contingent upon receipt of payment in full, terms are non-cancellable.
